ORDER DENYING PLAINTIFF'S MOTION

Pending before the Court is PLAINTIFF MICHAEL BYNOE's *Motion in Response to Order for Response* ("Motion"), filed on November 30, 2021. On December 20, 2021, PLAINTIFF filed a *Request for Submission*, submitting the Motion for the Court's consideration.

In the Motion, PLAINTIFF, in pro per¹, requests a "final ORDER or otherwise, to settle adjudicate the First Amended Complaint filed 2-9-21." Motion, p. 1.

However, PLAINTIFF has failed to comply with the basic rules of civil procedure and is not entitled to judgment on the pleadings at this stage of litigation. To proceed to judgment, PLAINTIFF must familiarize himself with the relevant procedural rules and/or retain counsel to ensure compliance. Failure to comply with applicable procedural rules

¹ Petitioner previously filed a *Motion for Appointment of Counsel* on September 16, 2020. However, because no request for submission was filed, the Court has not considered that motion. Additionally, Petitioner shall be advised that the motion for counsel was for a postconviction petition for writ of habeas corpus and not for a civil action sounding in tort.

may result in filings being stricken and even the case being dismissed.

While the Court recognizes that PLAINTIFF is incarcerated and without an attorney, "in general, the rules of civil procedure 'cannot be applied differently merely because a party not learned in the law is acting pro se." *Rodriguez v. Fiesta Palms, LLC*, 134 Nev. 654, 659, 428 P.3d 255, 258-59 (Nev. 2018) (quoting *Bonnell v. Lawrence*, 128 Nev. 394, 404, 282 P.3d 712, 718 (Nev. 2012)). "While district courts should assist pro se litigants as much as reasonably possible, a pro se litigant cannot use his alleged ignorance as a shield to protect him from the consequences of failing to comply with basic procedural requirements." 134 Nev. at 659, 428 P.3d at 259.

Because PLAINTIFF has failed to adhere to the Nevada Rules of Civil Procedure, IT IS HEREBY ORDERED the Motion is DENIED.
