## NOTICE OF SUPPLEMENT TO THE STATE ENGINEER'S EMERGENCY MOTION UNDER NRAP 27(E) FOR STAY OF DISTRICT COURT'S CORRECTED ORDER GRANTING SOLARLJOS, LLC'S MOTION FOR PARTIAL SUMMARY JUDGMENT AND STAY OF ADJUDICATION PROCEEDINGS PENDING APPEAL AND REQUEST FOR TEMPORARY STAY PENDING DECISION ON UNDERLYING MOTION FOR STAY

Appellant, the State of Nevada, Department of Conservation and Natural Resources, Division of Water Resources, and Adam Sullivan, P.E., in his capacity as the Nevada State Engineer (hereafter "State Engineer"), by and through counsel, Nevada Attorney General Aaron D. Ford, Senior Deputy Attorney General James N. Bolotin, and Deputy Attorney General Ian Carr, hereby files this Notice of Supplement to his Emergency Motion for Stay Pending Appeal.

As stated in the State Engineer's Emergency Motion for Stay Pending Appeal, part of the emergency basis for the State Engineer's request was the upcoming hearings on exceptions "scheduled for March 3–4, 2022, March 8–10, 2022, and continuing for 2 to 3 days each week through the second to last week of April 2022." State Engineer's Emergency Motion for Stay Pending Appeal, p. 9. The State Engineer stated that "the district court's order denying the State Engineer's Motion for Stay brings into direct question what the State Engineer's role should be in these upcoming hearings," citing that order attached to the Motion as Exhibit 7.

Yesterday, on February 28, 2022, the State Engineer was served with subpoenas by Eureka County for two of his staff members (Dan Taylor and Jared McCrum) to testify at the upcoming hearing on exceptions scheduled for March 3–4, 2022. *See* Subpoenas for Dan Taylor and Jared McCrum, attached hereto as Exhibit 8.<sup>1</sup> Eureka County did not subpoena the State Engineer or DWR personnel in previous hearings on exceptions, and this change in strategy seems to stem from the previously referenced question regarding the State Engineer's role in these hearings in light of the district court's February 24, 2022, order denying the State Engineer's Motion for Stay.<sup>2</sup> The issuance of these subpoenas creates further uncertainty as to the role of the State Engineer in the proceedings in the district court.
