19 THIS MATTER having come on for hearing before the above entitled Court on the  
20 20th day of July, 2021, the Defendant not being present, IN PROPER PERSON, the Plaintiff  
21 being represented by STEVEN B. WOLFSON, District Attorney, through KAREN  
22 MISHLER, Chief Deputy District Attorney, without argument, based on the pleadings and  
23 therefor,

1 The Court noted no parties present; ORDERED, Defendant's Writ of Prohibition  
2 DENIED as prohibition is the incorrect remedy for Defendant's request of the Court to order  
3 Nevada Department of Corrections to cease and desists from removing funds from his inmate  
4 account to pay restitution; a writ of prohibition may only issue where there is not a plain,  
5 speedy and adequate remedy in the ordinary course of law. NRS 34.330. See also Sonia F. v.  
6 Eighth Jud. Dist. Ct., 125 Nev. 495, 498, 215 P.3d 705, 707 (2009). Therefore, Defendant has  
7 other administrative remedies available to him to obtain the remedy in which he is seeking.

8 This Court further finds that Defendant is not entitled to the appointment of post-  
9 conviction counsel. Coleman v. Thompson, 501 U.S. 722, 752, 111 S. Ct. 2546, 2566 (1991).  
10 Lastly, this Court finds that Defendant s challenges to the conditions of confinement should  
11 be responded by the Attorney General s office. As such, this COURT FURTHER ORDERED,  
12 the Attorney General s office to file its response to Defendant s challenges to the condition of  
13 his confinement no later than July 29, 2021.
