Dear Ms. Meeks,

Please consider the following in regard to your questions posed to me following my conversation with Assistant Bar Counsel Gerard Gosioco. I do not remember specifically the time period of when I was employed by Jeremy Bergstrom. I do recall being employed in his then-office for at most two-weeks, and I recall being involved in some collections work. As an associate in the office during this time, I did appear as counsel of record on some cases, and this would have been reflected on the pleadings or on a relevant complaint.

My review of the Nevada Supreme Court's website, which contains the disciplinary history of Mr. Bergstrom, served to refresh my memory, to some extent, of my time there. Specifically, the disciplinary matter filed in the Supreme Court on December 21, 2018, entitled ORDER OF SUSPENSION, does provide a relevant time frame to allow me to describe the following to you.

I recall working for Mr. Bergstrom for the very short period described above and learning from colleagues or otherwise being made aware from sources other than Mr. Bergstrom of a disciplinary matter, which at the time, along with others, was seen as a suspension of Mr. Bergstrom. (I do see as I review the December 21, 2018 Supreme Court order that despite its title, apparently given the stayed nature of the suspension, Mr. Bergstrom was actually put on probation). At the relevant time, the understanding that I had was that Mr. Bergstrom was suspended. Upon learning of this disciplinary action, not wanting to be a part of an office attributed to Mr. Bergstrom, I did quit without notice from the firm. In reference, in part, to your inquiry of me, I do not recall how long this initial period, if you will, lasted, but it would have been most likely just a few days. Over those days, I did reconsider and I did return for a maximum of two days and then left permanently thereafter. Looking back, the best I can recall by way of an explanation regarding this time period, is that again, I left, or quit, because I understood Mr. Bergstrom was suspended. I returned for the brief period, as described, for professional and family-related reasons. Of course, given that I understood that Mr. Bergstrom was suspended during the few days of my return, I did nothing to assist with anything that would even have the appearance of unauthorized practice of law on Mr. Bergstrom's behalf. After the maximum two days of my return, I simply thought better of it and left permanently. Since the

disciplinary matter relevant to the above scenario occurred in December 2018, that appears to be the timeframe in which all the above occurred, as described.

I have reviewed the process server list of cases, or court records, contained in your email. In reference to your question as to whether I recall initiating the complaints filed in these cases, the answer is no. Further, please know that prior to my employment with Mr. Bergstrom and subsequent thereto as well, I had no contact or relationship or involvement whatsoever with him or any office he purported to be a part of. Therefore, since the first I've known of any of these filings bearing my name was when I received that information from you, it is apparent to me that, assuming the court records document is accurate, someone utilized my name without my knowledge or authority, as I had nothing to do with any of the cases where my name appears following my departure from Mr. Bergstrom's office. Further, as to your inquiry as to whether I recall filing any of the Notice of Change of Attorney in the Firm documents, likewise, I first became aware of those as well upon receipt of your court records document. Therefore, just as I did not authorize my name to be used on any of the complaints, I likewise, of course, gave no authority regarding the Notice of Change filings that appear in your court records list, as well. I did note that on page 4 of the court records document there are a few filed dates that preceded my employment at Mr. Bergstrom's office, and likewise include a Notice of Change of Attorney in the Firm item listed. I don't recall filing these matters either, especially in light of the fact I had no prior relationship with Mr. Bergstrom.

Given the overall disciplinary history of Mr. Bergstrom that is evident from the Supreme Court's website, in conjunction with the court records document you provided, one may reasonably conclude that it was Mr. Bergstrom who used my name on all these cases without my knowledge or authority. However, of course I will leave that conclusion up to you. Suffice to say, I appreciate you bringing this to my attention, and am aggravated and surprised to see that my name was used in this way.
