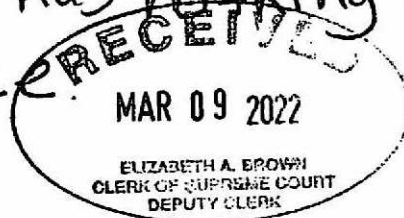

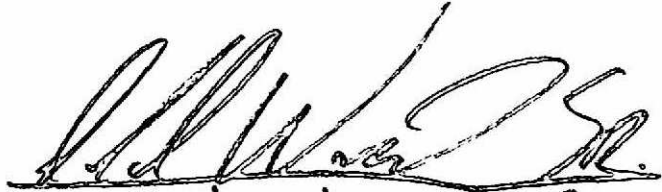
my every attempt to serve said documents have been delayed, detoured, hindered and stopped in every way.

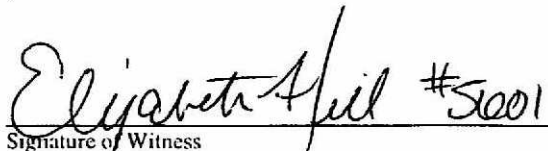
