Counsel Neidert addressed and advised the Court that he has had enough time to speak with his client and they are ready to proceed.

COURT reviewed the Motion for Bail Reduction filed July 24, 2020 and the Opposition to Motion filed July 31, 2020.

Counsel Neidert addressed the Court and argued in support of the Motion for Bail Reduction pursuant to the Valdez-Jimenez standard.

Counsel Neidert reviewed Frye v. District Court.

Counsel Samples addressed and advised the Court that the State does not dispute that NRS 178.498 and NRS 178.4853 apply to this hearing.

Counsel Neidert presented further argument in support of a bail reduction to \$10,000 bondable and/or and own recognizance release and provided a procedural background of the Defendant's prior case and the case at bar. Counsel Neidert further addressed concerns regarding the possible intimidation of witness Shannon Mendoza.

Counsel Neahusan advised the Court that the Defendant wishes to withdraw his Motion for a Young Hearing and withdraw his Motion to Withdraw his Guilty Plea and proceed today with sentencing. Counsel Samples addressed the Court and requested that the record reflect that the PSI has been reviewed by Counsel and the Defendant.

COURT ORDERED Imprisonment in the Nevada Department of Corrections is imposed for a maximum term of one hundred forty-four (144) months with a minimum parole eligibility of sixty (60) months, with credit for time served of one thousand one hundred forty-four (1144) days.

COURT ORDERED Payment shall be made to the Clerk of the Second Judicial District Court as follows: Twenty-Five Dollars (\$25.00) administrative assessment fee, Three Dollar (\$3.00) administrative assessment to obtain a biological specimen and conduct a genetic marker analysis and Five Hundred Dollars (\$500.00) for legal representation.

COURT FURTHER ORDERED Restitution shall be paid in the amount of Five Thousand Eight Hundred Sixty-Five Dollars and Ninety Cents (\$5865.90) to victim Department of Family Services, through the Division of Parole and Probation. Pursuant to Article 1, Section 8 of the Nevada Constitution, all monetary payments, money, and property collected from the Defendant shall be first applied to pay the amount ordered as restitution to victim Department of Family Services, Nev. Const. art. 1, §8. Any restitution, fine, fee, and administrative assessment imposed by this Judgment of Conviction constitutes a lien, as defined in Nevada Revised Statutes NRS 176.275. Should the Defendant fail to pay any restitution, fine, fee or assessment imposed, collection efforts may be undertaken against him.

Defendant remanded to the custody of the Sheriff.
