JUDGMENT OF CONVICTION

The Defendant entered a plea of guilty and no legal cause being shown as to why judgment should not be pronounced against Garret James Reuben Vigil, Jr., the Court rendered judgment as follows:

- 1. That Garret James Reuben Vigil, Jr. is guilty of the crime of Attempted Coercion With Physical Force or Immediate Threat of Physical Force, Constituting Domestic Violence, a violation of NRS 193.330, being an attempt to violate NRS 207.190.2a, a category C felony, as charged in the Information.
- 2. That Garret James Reuben Vigil, Jr. be punished by imprisonment in the Nevada Department of Corrections for a minimum term of 19 months to a maximum term of 48 months, with credit for time served in the amount of 6 days.
- 3. It is further ordered that Garret James Reuben Vigil, Jr. shall pay an administrative assessment fee of \$25.00 and the \$3.00 administrative assessment for obtaining a biological specimen and conducting a genetic marker analysis, a \$35.00

domestic battery assessment and reimburse the County of Washoe the sum of \$500.00 for legal representation to the Clerk of the Second Judicial District Court.

- 4. Pursuant to NRS 202.360, it is further ordered that Garret James Reuben Vigil, Jr. is prohibited from owning, possessing, or having under his custody or control any firearm; Garret James Reuben Vigil, Jr. shall permanently surrender, sell, or transfer any firearm that he owns or that is in his possession or under his custody or control. Further should Garret James Reuben Vigil, Jr. violate any provision included in this Judgment of Conviction concerning the surrender, sale, transfer, ownership, possession, custody, or control of a firearm he shall be guilty of a category B felony and shall be punished by imprisonment in the state prison for a minimum term of not less than 1 year and a maximum term of not more than 6 years and may be further punished by a fine of not more than \$5,000.00.
 - 5. Garret James Reuben Vigil, Jr. is hereby advised that:

Any fine, fee administrative assessment or restitution imposed today (as reflected in this Judgment) constitutes a lien, as defined in Nevada Revised Statute NRS 176.275. Should the Defendant not pay these fines, fees, or assessments, collection efforts may be undertaken against him.
