

Hi Caleb:

I hope everyone there is safe and well under the current situation of our Nation and Globally, with regard to the Coronavirus (COVID-19). I have been waiting on current news of this situation to determine a decision best for Miss Sydney Rose and me for our scheduled timeshare during her Spring Break beginning Saturday, March 21st. I appreciate your email relaying your concerns and offer of an additional week during the Summer break with Miss Sydney Rose and will agree to allow her to remain with you at your home in Philomath, Oregon, due to the concerns with Coronavirus (COVID-19).

I would absolutely love to exercise my time-share with Miss Sydney Rose as I believe it is in her best interest to spend time with me, her mother, as well as, her family here. Otherwise, it will be six (6)-months from our last visit together until her time off for the Summer; we are also missing each other's birthdays, most importantly her birthday celebration with her family here. It is important for her and I to enjoy regular contact with each other.

I understand and appreciate your concerns about the Coronavirus (COVID-19). It is my understanding that there are currently more cases of Coronavirus (COVID-19) in the State of Oregon, which is in between the two hotspots of Washington State and the State of California, than in the State of Nevada. Also, I believe that children have been very resilient but could pass it on to someone else if they have it, just like anyone else. I am not ill nor is anyone in my immediate family, and I believe that I can keep Miss Sydney Rose as safe as you can keep her under the circumstances; especially, since she is apparently out of school and has been out of school unbeknownst to me as you did not notify me of same.

Since Miss Sydney Rose is out of school, I am requesting that I keep her for more time as the reason for the visit is because she is off school and has the time to spend with me since that is the only time she gets to spend with me. Therefore, it would only make sense for Miss Sydney Rose to be able to stay longer with me since she is apparently out of school through at least April 28, 2020,

according to the Philomath School District's website. Is she currently completing school work from home and Zoom class sessions or will this time away from school be made up during the Summer break? If so, my concern is our scheduled time together for the Summer will then be delayed due to this, which will only further prolong our time apart. Please provide me with an update. *Additionally, is she up to date with her immunizations and has she received a flu shot this year and last year? Please provide me with her immunization records, to include flu shot records and records concerning her Staph infection, as previously requested. I would also like a copy of her school records for this current school year, including her progress reports/grading records. I truly appreciate these updated records and information.*

Currently, I had already procured flights, the first of which arrives this evening, March 20th, picking up Miss Sydney Rose tomorrow morning, March 21st at 9:00 a.m., returning to our home in Las Vegas on a flight shortly thereafter; travel/flights have not been banned within our Country. Again, I have and will always do my best to keep Miss Sydney Rose safe and away from any person(s), who may be ill, with her best interest at heart, as I have always done and continue to do. This is a time where it should be agreed that she can spend a longer time with me; especially, in light of these circumstances as I can comfort her.

With this being said, however, and in considering the current state of our Country and with Miss Sydney Rose's best interest at heart, I definitely do not want to place her in a position during travel between Portland and Las Vegas to possibly become in contact with this virus. I am in no way foregoing my timeshare with her, but will agree to allow her to remain with you at your home in Philomath, Oregon due to the concerns with Coronavirus (COVID-19). I would love for her and I to spend our time together as scheduled, as this time is so special and important for us both, and hope to be making-up this time by this Summer, if not sooner. I think it best for her and I to enjoy regular weekly video calls via cellphone, Zoom or Skype sessions as previously requested and noted within our Order, as well as, regular weekly phone calls at least three (3) per week. I would also like to see if you would be in agreement to her and I enjoying time on a weekend or two before our Summer timeshare once the COVID-19 concern resolves, businesses re-open and we return to a state of normalcy. Otherwise, it would be nearly six (6)-months or possibly more depending on her school schedule for her and I to spend time with one another.

Looking forward to your thoughts at your earliest possible convenience. Thank you in advance. In the interim, I am wishing for Miss Sydney Rose to be safe and well during this time and will be reaching out to her again this evening in an attempt to speak with her. She is more than welcome to call me anytime, as always. We both miss each other very much. Thank you again.

Allegations of Neglect and Threat of Harm (DV) to Sydney Myers Haskins (10yo) by her father, Caleb Haskins and step mother, Valerie Sullivan.

It was reported that on 11/2/20, Sydney Myers Haskins (10yo), has indicated that she feels "sick to her stomach" and is reported to be experiencing extreme ^{Confidential Child Welfare} stress, reportedly due, to the ongoing family condition in the home, which is reported to be "chaotic and out of control." Reporter informs that on 6/12/20, when Sydney went to visit her mother, Lisa Myers in Arizona, Sydney expressed concern for her safety, as she indicated that both of her parents, Caleb Haskins and Valerie Sullivan will reportedly drink and drive while impaired by alcohol, with Sydney in the vehicle, in order to get more alcohol. It was reported that both parents, will reportedly engage in verbal altercations which will become physical to the extent that Sydney reports that her stepmother, Valerie and father, Caleb, will physically punch each other, while they are both impaired by alcohol. Reporter expressed concern for Sydney, as she indicated that she has only eaten a slice of pizza since she got back to her father' home on 11/3/20 and was able to eat a piece of peanut butter and bread on 11/2/20, as Sydney indicated that neither, Valeri, nor Caleb, will cook for her and expect her to feed herself and wash her own clothing; ^{Confidential Child Welfare (8)}

as it was reported that step sibling, Malachi (15yo) has reportedly came into her room on 11/2/20 in the middle of the night, reportedly to verbally assault her and call her derogatory names, while their parents were asleep. No marks nor bruises were reported to Sydney at this time. These concern meet criteria for Present Danger, as the family condition appears to be significant and out of control, which if left unchecked, may result in severe harm to any child in the home.

REPORT NARRATIVE:

Report Summary:

Sydney Myers Haskins (10yo) and Malachi Zambrano (15yo) reside with their legal parents, Caleb Haskins ^{Personal Nature (4)} and Valerie Sullivan ^{Personal Nature (4)} who reside at ^{Personal Nature (4)} as well as ^{Other Individual (6)} 15-year-old girlfriend, (Unknown), who is reported to be pregnant.

ETHNICITY AND LANGUAGE:

Reporter identified the family as White and English speaking.

ALLEGED PERPETRATOR and VICTIM:

Parents, Caleb Haskins and Valerie Sullivan were identified as the alleged perpetrator to Sydney Myers Haskins (10yo).

Screen/System Names (18) Sydney (10yo) is unable to be located in database, her parents were reported to be Caleb Haskins and Lisa Myers Personal Nature (4) who resides out of the home at Personal Nature (4) she is reported to have visitations with Sydney every major holiday and also during the summer, she recently had Sydney from 6/13/20- 11/1/20 in her care; Caleb is reported to be the primary caregiver for Sydney.

Screen/System Names (18) Malachi's (15yo) parents are reported to be Valeri Sullivan and Jose Guadalupe Zambrano, who resides out of the home at Personal Nature (4) visitation schedule unknown.

EXTENT OF ALLEGED ABUSE

It was reported that on 11/2/20, Sydney Myers Haskins (10yo), has indicated that she feels "sick to her stomach" and is reported to be experiencing extreme Confidential Child Welfare stress, reportedly due, to the ongoing family condition in the home, which is reported to be "chaotic and out of control." Reporter informs that on 6/12/20, when Sydney went to visit her mother, Lisa Myers in Arizona, Sydney expressed concern for her safety, as she indicated that both of her parents, Caleb Haskins and Valeri Sullivan will reportedly drink and drive while impaired by alcohol, with Sydney in the vehicle, in order to get more alcohol. It was reported that both parents, will reportedly engage in verbal altercations which will become physical to the extent that Sydney reports that her stepmother, Valerie and father, Caleb, will physically punch each other, while they are both impaired by alcohol. Reporter expressed concern for Sydney, as she indicated that she has only eaten a slice of pizza since she got back to her father' home on 11/3/20 and was able to eat a piece of peanut butter and bread on 11/2/20, as Sydney indicated that neither, Valeri, nor Caleb, will cook for her and expect her to feed herself and wash her own clothing; Confidential Child Welfare (8) it was reported that step sibling, Malachi (15yo) has reportedly came into her room on 11/2/20 in the middle of the night, reportedly to verbally assault her and call her derogatory names, while their parents were asleep. No marks nor bruises were reported to Sydney at this time.

CIRCUMSTANCES OF ALLEGED ABUSE

Reporter informs that Sydney (10yo), who has recently returned into her father's care as of 11/1/20, has expressed ongoing concerns regarding feeling Confidential Child Welfare (8) "sick to her stomach," reportedly due, to the ongoing family condition at her father's home, which is reported to be "chaotic and out of control." Reporter informs that on 6/12/20, when Sydney went to visit her mother, Lisa Myers in Arizona, Sydney expressed concern for her safety in general while she is living in her father's home, as she indicated that both of her parents, Caleb and Valeri will reportedly drink and drive while impaired by alcohol, with Sydney in the vehicle, in order to get more alcohol, typically in the middle of the night at the local convenience store down the road; reporter informs that Sydney did not report any form of accidents occurring from this, other than

indicating that she did not feel safe because she knew her parents were impaired by alcohol. It was reported that both Caleb and Valeri will reportedly drink alcohol heavily on a regular basis, as it was reported that Valeri is reported to have a medical condition (unknown) where she reportedly likes to mix her medications with alcohol, as it supposedly helps her sleep well, where it was noted that both parents will take multiple "shots" of hard alcohol before they go to sleep.

Reporter informs that Valeri will reportedly sleep walk or get up in the middle of the night, where she appears to be impaired by alcohol, where she will reportedly knock over things in the living room, while she appears to be asleep and will sometimes open the door and fall asleep outside in the front lawn, leaving the door to the home open; it was reported that this occurs regularly according to Sydney. Reporter informs that Caleb is reported to have served in the military from 2006-2007, where he was reportedly discharged due to mental health concerns, where he is reported to have been diagnosed with PTSD and has a traumatic brain injury; he was reportedly prescribed "Lamictal," however, it is unknown if he is currently taking any medication, nor if he is currently seeing a mental health provider for these concerns. It was reported that when the parents fight, Caleb will usually leave the home for a couple days.

Reporter informs that Sydney indicated that her parents will reportedly engage in verbal altercations which will become physical to the extent that Sydney reports that her stepmother, Valorie and father, Caleb, will physically punch each other, while they are both impaired by alcohol on an ongoing basis; reporter informs that Sydney has indicated that everyone in the home appears to smoke marijuana, including Malachi (15yo), where Sydney is unsure what her parents smoke exactly, however, it was noted that Malachi has been caught with marijuana in the home by his parents, which don't condone him using, however, it was noted that they do not appear to be able to redirect Malachi, as he is reported to be a youth with significant oppositional defiance and has been noted to become quickly escalated, as well as verbally and physically abusive when challenged.

Reporter expressed concern for the safety of Sydney, as she indicated that she has only eaten a slice of pizza since she got back to her father's home on 11/1/20 and was able to eat a piece of peanut butter and bread on 11/2/20 through the entire day, as Sydney indicated that neither, Valeri, nor Caleb, will cook for her and expect her to feed herself and wash her own clothing. Reporter expressed additional concern for Sydney, as she reported that her step brother, Malachi (15yo) has reportedly come into her room on 11/2/20 in the middle of the night and reportedly verbally assault her and call her derogatory names, while their parents were asleep; it was reported that later in the day, Malachi did the same thing, however, this time around he was escalated and reportedly broke Sydney's TV in her room and called her derogatory names, regarding his alleged substance use regarding marijuana; it is unknown exactly what prompted Malachi to do this, however, it was noted that his is common behavior, as it was reported that historically, Malachi has "bullied" Sydney and has reportedly pushed her around; no marks nor bruises reported historically, nor today.

Reporter informs that Sydney is reportedly disciplined via use of taking away privileges and getting sent to her room for a time out, however, it was reported that Sydney will not be allowed to go to sleep and has to stay in the corner of her room and is also reportedly not allowed to use the rest room, as she has reported that she has had to urinate on herself, in order to comply with this mandate by both of her parents. It was reported that historically, both Caleb and Valerie would reportedly use a wooden spoon or their hands, to "smacked" Sydney on the mouth and bottom, arms or legs; historic marks were reported but not today. Reporter informs that when Sydney gets her cell phone taken away, Valeri will reportedly threaten to smash it with a hammer, so that Sydney is unable to keep in contact with her mother in Arizona; it was noted that Sydney has called her mother in Arizona mover 16yo times since she got to her father's home in Oregon on 11/1/20.

Reporter described Sydney (10yo) as developmentally on track, who participates in pageants shows in Nevada and has two titles; she is reported to be doing well academically, and was recently seen by a doctor in AZ , where it was reported that she has been gaining weight, while in her mother's care, as it was reported that she was 30lbs underweight, while she was living in Oregon with her father, which they believed was attributed to Sydney not being given enough food to eat.

Reporter informs that in the home is older step sibling, Other Individual (6) who is reported to have a 15-year-old girlfriend (Unknown) who also lives in the home and is reportedly due to give birth anytime soon today in the home.

Reporter does not know much information about this arrangement; however, it was noted that both Valeri and Caleb are aware of the age differences between Other Individual (6) and his girlfriend. Lastly, reporter informs that older step siblings, Other Individual (6) is reported to be wheel chair bound, who is reported to need assistance with feeding and getting his diaper changed, where it was noted that Sydney has been tasked by Valeri to feed Other Individual (6) via spoon on an ongoing basis, as reportedly had Sydney sleep in the same bed with Other Individual (6) historically (Unknown for how long nor why); there were no disclosures of sexual abuse disclosed by Sydney against Other Individual (6) at this time. Reporter informs that given all of these concerns, they believed that Sydney is currently in danger, as neither one of her parents appears to protective nor willing to meet her needs, as they expect her to take care of herself and her older brother, Other Individual (6) (reporter informs that older siblings/adults change Other Individual (6) diapers).

*****CW HISTORY*****

Allegations of Neglect and Threat of Harm (DV) to Sydney Myers Haskins (10yo) by her father, Caleb Haskins and step mother, Valerie Sullivan have not previously been assessed, as no record regarding Sydney has been reported to ORCAH until today per Orkids review.

EXTENT OF THE CHILD ABUSE OR NEGLECT:

This report was received at the Oregon Child Abuse Hotline in the afternoon on 11/02/2020, was referred to Corvallis CPS that evening, and assigned to me the next morning. I had previously worked with this family and was somewhat aware of family background, and further reviewed family history and background via OR-Kids, Screen/System Names (18) and social media.

Prior to my assignment I received a call as the assigned after-hours on-call worker from Philomath Police Officer Mark Koeppel who alerted me to his response to the home to see the child, Sydney Haskins Myers, who was emotionally distraught and wanting to leave the home. He shared with me that he completed a welfare check on her in the home and although she had many concerns to share, they did not constitute child abuse or neglect and that there was no probable cause to suspect a crime occurred. Both he and I had previously worked with another child in the home, Malachi Zambrano, and agreed that he was not an appropriate teen to be left to care for Sydney without a parent home because of his own behavioral issues, which is what Sydney was reporting was happening. I let him know I would be asking to be assigned when the referral came from screening and that I would check on Sydney. Prior to the case closing I had passed on my findings and he still had no probable cause, thus closing his case.

After receiving the referral on the morning on 11/03/2020, I contacted the mother in Nevada, Lisa Myers, to gather family information and current status of custody and her knowledge of how Sydney was doing. Ms. Myers spoke of a long history of conflict with Sydney's father, Caleb Haskins. She pointed out that she is primarily concerned for Sydney's safety and is prepared to come to Oregon to take her home if needed. She stated that she spoke to Sydney after she arrived at her Dad's house a few days ago and that Sydney was distraught, not eating, Confidential Child Welfare (8) Ms. Myers did not share that Sydney made any specific statements about unsafe behavior, but that she had complained that Malachi was being mean to her, that Mr. Haskins' wife Valeri Haskins (AKA Sullivan) was treating her poorly, and that she was alone in her room. I inquired about anything Ms. Myers had observed or heard herself and she said that when she was talking to Sydney Mr. Haskins hung the phone up, which was a cause for concern. I asked Ms. Myers if there was any pending motions or changes within the custody agreement and she stated that she was attempting to gain custody of Sydney and that they had a hearing coming up in January. She pointed out that she wasn't sure what was going on, and that she hoped I could check on Sydney. She said she didn't want to make assumptions and fly to Oregon to confront Mr. Haskins without accurate information. I told her I would let her know what I observed when I checked in on Sydney that day. I also gathered family functioning and parenting information from Ms. Myers reflected elsewhere in this assessment.

Next I spoke to Mr. Haskins. I had left him a message and he promptly returned my call. I informed him that I received a call from our hotline concerned for Sydney and asked him to tell me about her

transition back to his house and about what has been going on over the last few days. He pointed out that he was aware the police were at the house before he got home from work and that they were all on edge in the home. He said Sydney was struggling emotionally with the transition, which is typical for her, but that this time it seemed even more difficult. He said he thought her mother called our hotline, I reminded him I don't talk about who called in, just that I check on what was called and he accepted that. He said Sydney hasn't been eating much and has been complaining of being anxious. He said she struggles with anxiety and that this has been a problem for years, ever since he got custody of her and visits at her Mom's house happened. He pointed out that her Mom has a history of severe mental health issues and that she puts ideas into Sydney's head to turn her against him. We talked about children in a custody battle struggling with who they are "supposed" to have allegiance for, and he was able to acknowledge that it isn't her job to please her parents, that they need to be able to support her through it. But he said that he and Ms. Myers cannot co-parent well at all. He ran through some of the history of their custody battle, pointed out that they've both made many allegations about each other, and that Sydney has been caught in the middle. Mr. Haskins shared that since Sydney arrived she's been quiet and crying a lot. He said they were able to have a good "heart-to-heart" a few nights ago and that he made it clear to her that he is here to support her and things will get better. I made plans with him to see Sydney later that morning because Sydney was still sleeping and usually woke up around 9:30am.

I visited Sydney at her Dad's home later that morning. I observed the home to be free of safety hazards and with ample resources for Sydney. She and I spoke alone in her room with the door closed. I asked her to tell me how things had been going since she got back to Oregon and she said she missed her Mom and wanted to go back to Nevada to make sure she was okay. I asked why she thought she wouldn't be okay, and Sydney said it was because she probably misses her. I asked if she's able to talk to her Mom and she said yes, on the phone when her Dad is home. Sydney shared with me that she didn't want to be in Oregon. She was ultimately able to articulate that she misses her Mom, she likes being an only child better in Nevada, that her Dad's house is louder and different than her Mom's, and that she felt like everyone was mad at her. She said since she arrived she had been yelled at by her stepbrothers, treated mean by her stepmom, and her Dad hasn't been home (he's been working). I used open-ended questions with Sydney and she did not corroborate any of the allegations that were in the initial report, just that she was very anxious and everyone was mean to her. She shared that she hadn't been eating because her stomach was upset from being so anxious, but that she had been offered regular meals and the opportunity to eat outside of meals if she felt like she could. Sydney was able to corroborate much of what Mr. Haskins shared had happened thus far as well. I asked more targeted questions around alcohol use and violence and she made no disclosures. I also completed a global safety interview and body safety interview with Sydney and she made no disclosures. Sydney also provided additional family functioning and family information reflected elsewhere in this assessment. I asked Sydney to stay in her room so I could speak with her Dad and I told her I'd check on her again soon.

I spoke with Mr. Haskins in the living room. I shared with him that I observed Sydney to be very upset and anxious and he showed appropriate concern. I pointed out that much of what had been reported was not what Sydney told me, and that it was apparent to me that he needed to focus on supporting her carefully while shielding her from everyone's opinions about her Mom. I also encouraged him to speak with members of the household about focusing on rebuilding relationships with her because she's 10 and isn't responsible for what her Mom says and that she can't help but be stuck between

her two parents who have conflict. He agreed and said he would be doing that, he also pointed out that he'd addressed Ms. Haskins treatment of Sydney with her and said that everyone in the house has hurt feelings and isn't doing the best job handling them. He asked for advice about how to navigate co-parenting and I encouraged him to talk to his attorney about how to manage custody, and I counseled him on the impacts of custody conflicts on children, and what parents can do to manage their own emotions and reactions so as not to drag their children through the mud. I pointed out that her anxiety about it is very severe, which tells me that she is aware of the conflict and is feeling it without having coping skills to manage. We discussed her dire need for counseling (which he addressed quickly after my initial contact). I addressed alcohol use and family conflicts with Mr. Haskins and he stated that he and Ms. Haskins drink responsibly, he denied ever driving while drunk (or seeing Ms. Haskins do so), he stated that they might have a drink when he gets home from work, but not every day. He said he and Ms. Haskins argue, and can raise their voices sometimes, but he denied them ever having physical fights or severe yelling matches. He said the only physical thing that has happened has been when he is redirecting Malachi's behavior (this has been previously assessed by DHS). Went spent a good amount of time talking about his conflicts with Ms. Myers as well. He said he doesn't believe she is a safe parent, but he's trying to help Sydney be with her Mom too. He said she is mentally ill and will not communicate with him. Mr. Haskins also provided additional family functioning and parenting information reflected elsewhere in this assessment.

Ms. Haskins was out of town attending to a new grandchild being born, so I called in in lieu of speaking to her in person upon my first visit. I explained that I had gotten a new call from the hotline and gathered information about how things have been going since Sydney arrived from her perspective. Ms. Haskins shared that things had been very emotional. She said she made a few mistakes and hadn't been the most supportive since Sydney arrived, but that overall, it had been okay. I asked what the mistakes were and she shared that when Sydney was being difficult she made a comment about her acting like Ms. Myers. She stated that she shouldn't have said it because Sydney can't help that she's struggling, and that she'd tried to mend things. Ms. Haskins shared that before this visit the family had received documentation from the custody court case, and that she read that Sydney and her mother made statements about Mr. Haskins, Ms. Haskins, and her sons that live in the home that made them all very upset. We talked about the fact that Sydney is a child and that the burden to manage through the conflict falls on the adults, and Ms. Haskins was able to admit it wasn't fair to resent Sydney for it. She pointed out that prior to this visit she and Sydney have always been very close, had a great relationship, and that she hopes they will get back to that point once they've been able to process everything together. I asked her how she thought Malachi has been doing with his step-sister back and she said he's been mean to her. She pointed out that he was aware of the court documents as well and that he was holding it against Sydney and had said mean things to her about talking about their family. She pointed out that he's a mean older brother in general (as older brothers can be), but that his feelings were hurt too. I let her know that there was information in my report that he was saying mean things and making Sydney feel unsafe and that it falls on her to intervene. She assured me adults would be home with Sydney going forward, that it was a one-time thing because she was out of town. Ms. Haskins also provided additional family functioning and parenting information reflected elsewhere in this assessment.

Following my contacts with Sydney and her family in Oregon I sent a summary text message to Ms. Myers to inform her of my observations and thoughts, encouraging her to contact me with questions or further comment but she never did.

Later that day I contacted Ms. Haskins to inform her that I needed to interview Malachi, as he wasn't home when I visited the home prior. She and I set up a time the next day for me to see Malachi. I saw him in the afternoon on 11/04/2020 at the Haskins' home. During my interview with him I also saw Sydney briefly and she told me things were going okay. She was playing with a friend and seemed to have higher spirits than the previous day. Malachi remembered me from previous interviews on other cases and he was willing to speak with me. During the discussion Malachi vacillated trying to be a "tough guy" and showing genuine concern for his family. I pointed out to Malachi that I was called to check in on Sydney. He scoffed and called her a brat. I asked him what had happened since she came back. Malachi shared that the family was really upset with her because of things she and her Mom said in their custody paperwork, and he said he hadn't been nice to her. I asked what happened. He explained that he went into her room and yelled at her and shut off her TV the day after she arrived. I asked if he did anything physically and he said no, and asked if she said he hit her. I told him no, but that I wanted to know what happened exactly. He said he'd been ignoring her since then. I asked how other people have been treating her and he said her Dad babies her. He said his Mom was upset with her and wasn't saying much to her at all. I completed a global safety interview with Malachi and he made no disclosures. When we discussed physical altercations in the home, he said he fights with Mr. Haskins (referencing my previous investigation involving Mr. Haskins restraining Malachi when he was out of control), but no one else gets physical. He said his Mom and Mr. Haskins yell at each other, but he feels like it is the typical level of bickering between married people. He also described their alcohol use as casual. Malachi provided additional family functioning and parenting information reflected elsewhere in this assessment.

Following my contact with Malachi I spoke to Ms. Haskins outside. She reiterated that she understood that she needs to keep her emotions in check and support Sydney because she's the child in the situation. I asked her some clarifying questions about what had transpired since Sydney arrived and he explained that she made an off-hand comment (that she admitted she wasn't proud of) about Sydney being just like her Mom, calling Sydney "Lisa" when she arrived. She pointed out again that she and Sydney have been close prior to this visit, and that this made her wounds even deeper when she read the court paperwork. She said she plans to try and mend the relationship and help Sydney settle in. I asked Ms. Haskins about substance use and violence in the home. She denied any sort of Domestic Violence or physical altercations between she and Mr. Haskins, Personal Nature (4)

pointing out that this is especially something

she will not tolerate within her marriage. She said they argue and fight like typical couples do, but it is never severe enough to be categorized as abusive. Ms. Haskins denied any drug use, stating that she cannot even use marijuana products because of its adverse effects on her. She said she does drink alcohol from time to time, but she rarely is drunk. She was adamant that she would never drive, and stated Mr. Haskins does not either. I asked her about sleep walking, as it had come up marginally in my report, and she explained that she has a history of sleep walking. She said there have been times that she has woken up in different places around the house, but she's never done anything violent or hurtful, that she's more zombielike. She said members of the household are aware and that they help keep her safe. She is working with a doctor to address the issue as well. Ms. Haskins also provided additional family functioning and parenting information reflected elsewhere in this assessment.

I attempted to gather records and Child Welfare history from Clark County, NV, where Sydney lived



with her parents prior to their separation, and where the custody case is established. Their agency sent back a letter stating that there were no substantiated allegations of abuse or neglect regarding Sydney. I called a caseworker who had worked with the family there previously Confidential Child Welfare (8)

She said Mr. Haskins appeared to try and get professionals aligned with him for the purpose of their custody case. She had no concerns she could recall about Mr. Haskins being a safe parent. She stated she would connect me with the District Attorney in Clark County, but that contact did not occur prior to my finishing this assessment.

CIRCUMSTANCES SURROUNDING THE CHILD ABUSE OR NEGLECT:

It's important to note in this case that Sydney's parents are currently engaged in an ongoing custody battle that has spanned most of her life. They are adversarial and not able to co-parent much at all. Both sides are frustrated with the other, and suspect abuse and neglect of each other that has not been able to be substantiated.

of my representation is to present the matter to the Court,

But I've not been hired to prepare anything. That's all done

19

by Mr. Haskins and some outside service.

20

THE COURT: Yeah. That -- I'll talk about the

21

filings that we got yesterday --

22

MR. ZERNICH: Yeah.

23

THE COURT: -- in that context. But do we have

24

Ms. Marr?

1 MS. MARR: You do, Your Honor. Thank you. Patricia
2 Marr, Bar number 8846. I'm appearing in a retained capacity
3 on behalf of Ms. Myers who is also present via BlueJeans as
4 well as Jessica Adams with our office.

5 THE COURT: Okay. That's fine. We -- okay. You
6 know, I feel like this has been like a piece of quicksand as
7 far as the time that's really been churning almost for the
8 last year. This case was reopened in September of last year
9 when Dad filed a motion to enforce the custody orders to get
10 relief from the Court to get the child returned to him. He
11 has primary custody. And those filings were in September.

12 Mom filed a response in October. And in her
13 opposition, she filed a counter motion addressing parent/child
14 issues she wanted to enforce her rights. She also said that
15 there were some issues related to custody. We had a hearing
16 in October, and granted, Dad's motion, and we started this
17 process where we allowed discovery in the efforts of giving
18 the parties an opportunity to get access to information that
19 could support a finding of adequate cause to reopen or re-
20 litigate the issue of physical custody.

21 So we had a hearing in January. And we talked about
22 this issue of limited discovery because there was -- were
23 allegations, but there was a need to try to follow up on those
24 allegations and get records and do some things you couldn't do

1 without having the right of discovery.

2 We continued the matter for a couple of months. The
3 last -- you know, there were stipulations to continue the
4 matter. The case was continued from January 13th to February
5 24th to March 31st to April 19th, then May 12th, then June
6 8th, and then the Court continued it to June 30th. And you
7 know, I -- the Court just basically said okay, you're working
8 behind the scenes trying to gather information.

9 And June 30th we said okay, look. You've had your
10 discovery period. But we need all of everything to be wrapped
11 up. And we required Ms. Marr, on behalf of her client, to
12 prepare what I call the prima facie affidavit, basically the
13 statement under oath making offers of proof that would show
14 that if those things were proven, the Court might consider a
15 change in physical custody.

16 And usually that's done at the beginning of a
17 request for a change. But in this case, it was tied back to
18 the opposition and counter motion that goes back all the way
19 to October. And we set a deadline for them. Ms. Marr met the
20 deadline. There was an affidavit that was filed on July 19th,
21 and it dealt with some general allegations.

22 I mean, Dad's had custody in Oregon for many --
23 several years. She alleged medical or dental neglect, some
24 domestic violence in his household. And she alleged that he

1 kept the child from her in spring break 2020. So Mr. Zernich
2 filed a notice of appearance a couple weeks later, and then
3 there was a substantive response filed yesterday, and also
4 some offers of proof, some exhibits filed yesterday.

5 And as Mr. Zernich says, he's helping Mr. Haskins,
6 but he's not doing all of the filings. That's something he'll
7 have to sort out.

8 So, Ms. Marr, first thing I want to know is did you
9 get the response that was filed yesterday and the offers of
10 proof, the exhibits?

11 MS. MARR: I received it this morning.

12 THE COURT: That's fine.

13 MS. MARR: I --

14 THE COURT: That's fine. That's fine. I mean,
15 whether you -- I just wanted to know whether you've seen what
16 the Court's seen. This is the problem, okay? The reason why
17 we had the hearing on June 30th, and why I said that we would
18 have a deadline in July for the filing of an affidavit, and
19 then presumably a response, was so that we could have a
20 discussion, or at least a record made of whether there's
21 adequate cause to reopen and set an evidentiary hearing, or
22 not adequate cause to set an evidentiary hearing.

23 And this is a case in which, based on the
24 allegations and the offers of proof, it's a close call. I

1 think the Court could determine that there's adequate cause
2 and set a hearing, or the Court could say no, there's no
3 adequate cause.

4 And why would I do that? It would be because
5 there's no, you know, Dad's response where he says there's no
6 DV in my household. And by the way, here are a copy of the
7 records from the Division of Family Services up in Oregon
8 which investigated it and closed it unsubstantiated. Or I
9 didn't deny her spring break. The pandemic hit in the spring
10 of 2020, and I gave her an extra week during the summer of
11 2020. Or I don't have any medical neglect or dental neglect.
12 The child isn't being neglected. My responsibilities are
13 being met. Those kind of things.

14 So those are the factual disputes because Mom has
15 alleged that there is domestic violence in his home, that
16 there was medical and dental neglect, and that he wrongfully
17 withheld the child from his custody. Okay?

18 So obviously, you know, that is sort of the type of
19 allegations that would warrant either a hearing or to
20 determine that there's no adequate cause for hearing. The
21 problem that I have is that the filings yesterday and the
22 attachments are relevant to that analysis. And Ms. Marr,
23 because of the timing of this filing, has been denied an
24 opportunity to reply or even, based on her statement that she

1 saw them this morning just like the Court did, you know,
2 respond to it.

3 That's not what we're supposed to be doing,
4 especially when this matter has been percolating and working
5 behind the scenes for months now. Okay? So I know Counsel's
6 probably prepared to, you know, weigh in on that. You know,
7 Ms. Marr, you're going to be asking the Court to find adequate
8 cause and set a hearing. Mr. Zernich, you're going to say no
9 adequate cause, deny it under the principles of Rooney, the
10 res judicata principles.

11 And I'm not having that with me considering material
12 stuff that was filed yesterday, okay? So you know, in June I
13 wanted everything to be on the record and to have no issues
14 related to what we were arguing. And it didn't happen that
15 way. And it's not -- not the Defendant's fault per se. And
16 it may not even be the Plaintiff's fault. You got to get the
17 stuff on record.

18 And so what I'm going to do to fix that is I'm going
19 to continue this matter a week or so, require you, Ms. Marr,
20 to respond to the offers of proof, the exhibits and the
21 response that was filed yesterday, and then you'll be able to
22 make your argument on the affidavit, the response, and the
23 reply because if the Court says there's no adequate cause to
24 re-litigate the issue of custody, you would have rights to

1 challenge that conclusion.

2 And if the Court finds that there's adequate cause
3 for an evidentiary proceeding, we proceed to setting an
4 evidentiary proceeding, and then we would decide it and then
5 rights would attach to that order. Okay?

6 So what I got in mind is setting it over a week or
7 so. September 7th at 10 would be my first choice. And I
8 would set a deadline for you to file a response. We could
9 start the clock running today. And that would mean that a
10 response would have to be filed by say the 27th, a week from
11 Friday. I'd give you a few extra days.

12 MS. MARR: Thank you, Your Honor.

13 THE COURT: And then everything would be in the can
14 so to speak on the 27th. We would be back in court a week
15 later. Mr. Zernich, I don't know what the scope is of your
16 unbundled representation. But, you know, you would be advised
17 that you can make an argument on behalf of Mr. Haskins at that
18 hearing. Okay?

19 MR. ZERNICH: Okay. Very good. So we have
20 September 7th at 10:00 a.m.

21 THE COURT: Right.

22 MR. ZERNICH: With August 27th deadline for --

23 THE COURT: That would be the -- look, I got -- I
24 got to be honest. I'm looking at the information that was

1 filed, I'm looking at the allegations that were made. You
2 know, I'm going to have to justify whether or not I say the
3 Court says no, we're not setting an evidentiary proceeding or
4 we are, and this is why. Okay?

5 MR. ZERNICH: Okay.

6 MS. MARR: Thank you. Your Honor, I appreciate
7 that. I'm good on my feet, but I'm not that good. And --

8 THE COURT: Well, no. And your client -- your
9 client is not going to be denied an opportunity to respond to
10 these records that she just got yesterday, or today.

11 MS. MARR: I think that --

12 MR. ZERNICH: Your Honor --

13 MS. MARR: -- the Court --

14 MR. ZERNICH: Patty and I -- Patty and I were on the
15 phone this morning talking about this very issue. And I
16 certainly have no objection. We anticipated this as part of
17 the -- what was going to happen. So we thank you for your
18 time. We're sorry to have not been ready to go this morning.

19 THE COURT: All right. Thank you very much.

20 MS. MARR: Not your fault, Gary. There's only one



37 LISA MYERS, being first duly sworn under the penalties of perjury makes
38 the following Declaration and deposes and says:

1 That I am the Defendant in the above-referenced action and respond to
2 Plaintiff's August 17, 2021 Declaration as follows:

3 2. Sydney's full legal name is Sydney Rose Myers-Haskins, however, Caleb
4 continues to refuse to use Myers at all on any legal documentation for school or
5 medical so I am excluded. He uses Sydney Haskins only and even corrects my
6 emails when responding to exclude Myers from Sydney's name;
7

8
9 4. Caleb was granted permission to relocate to Oregon in 2014, however, he
10 had already relocated without my or the Court's permission or knowledge, leaving
11 Sydney Rose behind to reside with his then wife, Charity Damesworth/Haskins'
12 former boyfriend. Charity then picked Sydney up from her former's boyfriend's
13 house in Nevada and drove her to Oregon herself. During this time I did not even
14 know Sydney was in Nevada, let alone living right down the street with me with
15 Charity's former boyfriend.
16

17 Caleb then moved from Oregon to Carson City, Nevada in 2014, again without my
18 or the Court's permission or knowledge where he resided for two (2) years.
19 During that time Caleb and Charity were going through a divorce and Charity
20 obtained a TPO against him due to Domestic Violence, which was on-going prior
21 to their relocation to Oregon.
22

23 I believe that Caleb filed his Motion to relocate with Sydney to Oregon under false
24 pretenses and that the true basis for his move was to restrict my contact with her
25 and avoid ongoing domestic violence investigations in Las Vegas, Nevada.
26

1
2 5. This is false as stated in my March 6, 2018, Motion filed by Attorney Kurth
3 and as evidenced in my subsequent pleadings on file herein. Specifically, Caleb
4 continues to refuse to allow Sydney Rose to call me, continues to refuse regular
5 phone contact or even commit to a time that she may talk to me; and refused to
6 allow her to spend time with me during Spring Break, 2020 - resulting in Sydney
7 and I not being able to spend her birthday, or my birthday, and we were not able to
8 see each other for six (6) months, albeit flights were not restricted during that time.
9 My phone contact with Sydney was limited during that time, as it always is.
10 More recently, Sydney and I have not been able to speak since the last child
11 exchange on August 13, 2021. These restrictions by Caleb are typical and when I
12 am permitted to speak to her it is typically limited to less than ten (10) minutes.
13 Further, my limited phone contact with Sydney, not by my choice, is often
14 interrupted with Caleb, Valeri or others, yelling, calling me names, partying in the
15 background, telling her to hang up the phone, or yelling/calling me derogatory
16 names before allowing Sydney Rose to speak with me. Further, Sydney's dental
17 records evidence that her mouth is overcrowded and she requires braces/Invisalign.
18 The Las Vegas dental records state Sydney is in pain and it is difficult for her to
19 eat.

20 6. This is false as noted in my March 6, 2018, Motion filed by Attorney Kurth
21 and as evidenced in my subsequent pleadings on file herein and the proposed
22 evidence to be introduced at trial. Specifically, Sydney's medical records in
23 Oregon evidence that she is vitamin D deficient; evidences low weight for her age
24 that she suffers from anxiety and that she spends the majority of her day watching
25 TV or playing video games.
26

1 7. False. I am aware from Sydney and Charity that Caleb has a history of drug
2 abuse, alcohol abuse and domestic violence. The drug use includes meth and he
3 was in a drug rehab at one time in northern Nevada and his current wife, Valeri has
4 a history of drug abuse to include ongoing use of pain killers for her back pain.
5

6 8. False. Evidence to be introduced at the time of trial, including, inter alia,
7 police records from LVMPD and Oregon State, including, TPOs involving Charity
8 Damesworth/Haskins his ex-wife and Caleb's own discovery responses, will
9 demonstrate Caleb's propensity for violence/domestic violence. He and his current
10 wife fight on a regular basis and there is an active case in Oregon. In addition to
11 the violence in Caleb's house with Valeri, Valeri has physically assault her son,
12 Malakai, and Malakai has physically assaulted others in the home, as well as
13 caused damage to property in the house.
14

15 Further, a recent CPS investigation was conducted because Caleb was drinking and
16 driving with his 9-year-old son, Mason and Sydney Rose in the car. Besides
17 drinking and driving with the children in the car, Caleb left them alone in the
18 vehicle to go into the liquor store to purchase alcohol and then opened it while
19 driving.
20

21 9. As stated herein, Caleb has withheld contact between Sydney Rose and I and
22 continues to do so.
23

24 10. There were not flight restrictions at the time of Spring Break 2020; airline
25 flights were still proceeding as normal despite the beginning of the pandemic.
26

1 Therefore, Sydney Rose could have traveled with me to Las Vegas. Ironically,
2 despite Caleb's refusal to allow Sydney and I to spend time together during Spring
3 Break, he demanded Charity allow him time with his son, Mason who resides in
4 another city. I had no choice but to succumb to Caleb's demand under the
5 circumstances, because he refused to bring her to the airport and upon professional
6 advice, I sent an email to avoid any issue from the Court later on.
7

8 As stated in prior pleadings, photos and videos, Sydney Rose refused to get on the
9 plane to return to Oregon due to her fear of Caleb and the household she lives in
10 while in Oregon.
11

12 11. As state herein, Caleb continuously interferes with my ability to have a
13 mother-daughter relationship with Sydney. Sydney has reported that Caleb has
14 torn up pictures of me upon her return to Oregon, broke and even thrown away her
15 matching necklace that we have purchased while in Las Vegas.
16

17 12. Again, Caleb continuously interferes and refuses to allow communication
18 with Sydney. In my emails to Caleb I have provided my information to Skype,
19 Zoom or Facetime, however, he refuses and has never allowed Sydney Rose to
20 communicate in that manner with me. Notably, Caleb stated in his 2014 Motion to
21 Relocate that he would allow this means of communication but has consistently
22 denied me and Sydney Rose of the ability to communicate by this these means.
23

24 13. Caleb has taken Sydney to his dentist, who is not a pediatric dentist and has
25 refused to get her ortho treatment. Caleb will not allow me to use my orthodontic
26

1 insurance in Las Vegas to provide her with the treatment needed even though I
2 have repeatedly told him my dental insurance will cover it and for any portion that
3 it does not, I am willing to pay. If Sydney Rose does get the treatment needed here
4 in Las Vegas, it could be either braces or even Invisalign and she will be provided
5 with all trays and just have check-ups with her pediatric orthodontist as needed
6 here as well. Sydney is in pain and has relayed that she is to me/our family and the
7 ortho/dentist at Mtn View in Las Vegas. It is disturbing that Caleb has told Sydney
8 that she does not need braces and that if she gets them, she will look like a
9 pretentious b&*%h like me. This should be about Sydney's dental health and the
10 fact that her mouth is overcrowded, she has trouble chewing and is in pain. It
11 breaks my heart that she doesn't like to smile because of the way her teeth look,
12 but again, that is secondary to her dental health and health in general.

13
14 14. There was an incident wherein Charity filed a false TPO against me (which
15 she will attest to) at the direction of Caleb. This occurred prior to 2014, prior to
16 Caleb's move to Oregon and apparently, done at the bequest of Caleb. The goal,
17 as stated to me by Charity, was to have me arrested and use it against me in the
18 custody case. Otherwise, I have always been at the airport to exchange Sydney
19 Rose, regardless if Caleb was in Carson City or Oregon, sometimes notifying me at
20 the last moment.

21
22 On one occasion Caleb failed to appear at the Oregon airport to pick up Sydney
23 Rose where Sydney and I were waiting for him to perform the exchange. Albeit
24 we were waiting at the airport for Caleb he called the police and misinformed them
25 that I was in Las Vegas and refusing to provide Sydney to him. At that time,
26

1 Sydney and I had to wait until the next day to perform the exchange.
2

3 15. I have never, nor do I currently have, any mental health issues. In this
4 regard, Caleb was previously admonished by this Court to stop making these
5 unfounded allegations, however, he continues to do so. Again, I have never been
6 diagnosed with a mental illness or concern.
7

8 16. As stated in my March 6, 2018 Motion, still pending before the
9 Court, and subsequent pleadings herein, Caleb relocated to Oregon prior to the
10 filing and granting of his Motion to Relocate. Caleb then relocated to Carson City,
11 Nevada due to DV/TPO/arrest concerns between Caleb and his then
12 Wife, Charity, where he resided for two (2) years in multiple locations in the city.
13 Caleb then returned to Oregon where he resided in multiple cities to include Salem,
14 Albany and Philomath. Sydney Rose attended a multitude of schools in Carson
15 City and Oregon, all without my knowledge or approval.
16

17 17. As stated herein and the pleadings and papers on file herein.
18

19 18. False. See Response to Paragraph Number 6. The proposed evidence
20 supports the same.
21

22 19. The current custody arrangement does not adequately foster Sydney Rose's
23 relationship with both parents; Sydney and I are unable to see each other or even
24 talk with each other on a regular basis. It is never difficult for Sydney Rose to
25 leave Caleb and go with me during these exchanges, however the opposite is true
26

1 with Caleb. Sydney Rose becomes ill, crying, throwing up and blatantly refuses to
2 return to Oregon with Caleb - this has been on going.
3

4 20. Caleb is not supportive, quite the opposite. In fact, Caleb has even stated in
5 emails and in Court that he wants nothing more than for me to be jailed. He
6 doesn't want Sydney Rose to see me or speak with me, speaks ill of me with
7 Sydney Rose telling her I am mentally ill/sick and a liar. He refuses to allow for
8 exchanges to go forth as scheduled, where she and I go without seeing one another
9 for six (6) months, and not speaking with one another over the phone for up to a
10 month at a time.
11

12 I have never and will never psychologically manipulate Sydney Rose, but Caleb
13 consistently mentally and emotionally abuses her. He and Valeri break her
14 necklaces and special gifts I have given to her. He has broken and thrown away
15 photo frames with my picture in them, even tearing up pictures of me, her brother
16 and grandparents.
17

18 As evidenced in the photos, videos and the numerous phone calls (46) in the couple
19 of days after Sydney returned to Oregon (11/2020), she relayed her fears regarding
20 him and the household and her desire to remain with me. Sydney Rose has a
21 loving, caring and stable, positive, non-abusive home here with me and our family
22 in Las Vegas.
23

24 21. I did contact DFS in Oregon and the Oregon Police Department for a well
25 check a result of Sydney Rose's conversation with me and her being in the house
26

1 in Oregon with Malakai, the juvenile with the ankle monitor who physically
2 threatened Sydney Rose. When speaking to Sydney, her demeanor was one of fear
3 and she was crying, demanding for me to pick her up and return her to Las Vegas,
4 and calling me non-stop. Trenton, Valeri's handicapped adult son, was in the
5 house. Trenton is handicapped, restrained to a wheelchair as he cannot walk or
6 move his hands/arms, wears a diaper and needs someone to carry him to the toilet,
7 change him, bath him and feed him as he is unable to do any of this himself. When
8 he is not in his wheelchair, his is lying on the floor on a blanket or mattress.
9 Sydney Rose feeds him on occasion, however, Valeri is his legal guardian/care
10 giver. Caleb was working in another city about forty-five (45) minutes away and
11 Valeri was two (2) hours away in another city as well. When Valerie and Caleb
12 are not at home, Sydney must care for Trenton.

13
14 At no time did I ever tell Sydney Rose she needed to act upset, this is absolutely
15 untrue. I did tape record all calls and document our trip to the airport when she
16 was originally scheduled to return in August, 2020, based upon her concerning
17 behavior and her refusal to board the airplane.

18
19 22. Police records and Charity's statement prove otherwise. Additionally, the
20 police/CPS has consistently been to the house in Philomath, Oregon as a result of
21 Malakai's violence and actions. There have also numerous TPOs filed as well.

22
23 23. That is unknown; however, Malakai possessed marijuana and Valeri does
24 possess pain killers and other drugs in the house.
25
26

1 24. That is unknown to me; however Charity has been to Caleb's house to pick
2 up and drop off their son, Mason, who has observed occurrences in the house while
3 there.

4
5 25. Caleb was never granted a TPO against me. Charity applied for a TPO at
6 Caleb's direction, however it was dissolved. Charity admits this and relayed the
7 abuse and threats by Caleb during their marriage while residing in Las Vegas and
8 Oregon to the courts. As a result of his abuse and concerns for their son Mason,
9 Charity was awarded Sole Physical and Legal custody of Mason with limited
10 visitation to Caleb.

11
12 26. Records from Charity, as well as her testimony evidence the abuse she
13 suffered while in a relationship with Caleb and her concerns regarding his
14 household.

15
16 27-30. Caleb has not provided updated progress reports, grades, assignments,
17 Events to me, nor has he allowed the school to provide me with any information
18 at all to include the Boys and Girls Club or physician/dental offices. He never
19 notified me of her graduation ceremony or special events. He never notified me of
20 her injuries sustained at the Boys and Girls Club or when she had a Staph infection
21 and was taken to the Urgent Care on two (2) occasions in Philomath. I only found
22 out when a bill arrived for nearly \$3k total and when I picked up Sydney Rose and
23 noticed she had a crater-shaped injury still healing on the side of her forehead. He
24 has never provided me with access to her school records whether at the school
25 directly or via their online parent log in despite my requests. He has never
26

1 provided any information with regard to her absences or his refusal to return her to
2 school when they returned to campus after COVID-19 this year. I have attempted
3 to contact the school and the other entities, however, they refuse to provide me
4 with any information as my name is not on the records as ordered by the Court.
5

6 31. This is relevant as to his relocations, despite the Court's Order and without
7 the Court's/my knowledge or permission. It is also relevant because it evidences
8 his instability and the veracity of my claims. Sydney Rose was in fact moved
9 around many times in and out of the State of Nevada and Oregon since the
10 relocation Order, attending many schools, residing in a multitude of places with
11 others to include Jodi, Caleb's friend, who had a warrant for her arrest.
12

13 32. Caleb never listed me as an emergency contact or even as her mother and
14 never notified me of this incident or others. He also never went to the Boys and
15 Girls Club to pick her up after they notified him of her injuries - more than one.
16

17 33. This video was provided to Caleb in my disclosures. Sydney Rose was
18 throwing up and crying incessantly, refusing to leave on the plane, begging me to
19 take her home with me. She did not want to return to Caleb and his household
20 in Oregon. Sydney Rose did not become upset at the airport due to her grandfather
21 passing nor did I make her feel guilty about wanting to return to Oregon, this is
22 absolutely false.
23

24 34. The Court will review the pleadings and papers on file herein, including my
25 offers of proof, and make a determination in the best interest of Sydney Rose. I
26

1 respectfully submit that the evidence will validate my claims and concerns that
2 there has been a substantial change that affects Sydney's welfare and the
3 basis for a modification of custody.
4

5 Paglini never testified in our case, nor was I ever evaluated by him in our case. I
6 was in a prior divorce matter (my ex-husband was a Metro police officer and was
7 abusive with myself and our son). Paglini worked for the police department at that
8 time and the report contained hearsay – statements by my ex-husband at the time.
9 That Court would not consider the Report. Regardless, Paglini never diagnosed
10 me in that Report and I went to three (3) separate psychiatrists/psychologists for
11 evaluations/forensic reports all which state no existing mental disease/defect. With
12 that being said, I have never been diagnosed by him or anyone with a mental
13 illness/disease or disorder. I am unsure as to how he would even have knowledge
14 of the report or of the contents of that report as that case is sealed and the report is
15 approximately fifteen (15) years old. This Honorable Court refused to entertain
16 this manufactured issue from Caleb and admonished him. More concerning is the
17 fact that Caleb frequently refers to me as crazy, sicko, schizo, baby killer and
18 mentally ill in front of Sydney or to Sydney.
19

20 I am a healthy, active mom; mentally and physically well without concern. I have
21 maintained employment as a Department Director/Chair for the Legal/Criminal
22 Justice and General Education Departments at a private College here in Nevada
23 for over six (6) years, have a teenage son who has been attending private school
24 and excelling in his academics and extracurricular interests. I have maintained a
25 strong, positive and loving relationship with my Sydney, despite all attempts by
26

1 Caleb to sabotage the same, as well as our family and provide her with the best
2 opportunities, and a healthy, happy lifestyle as evidenced. As noted above, the
3 Court has admonished Caleb from making these desperate and defamatory
4 statements to the Court.

5
6 Caleb, however, has been diagnosed with Medium to Severe PTSD with night
7 terrors, was prescribed Lamictal by the VA (this is a medication used in treating
8 bipolar/mood disorder), has a TBI, history of drug and alcohol abuse (incl'ing
9 Meth). He receives approx. \$450/mo in VA benefits for his diagnosed TBI/PTSD.
10

11 I am competent to make this declaration. I have personal knowledge of the
12 matters and factual averments contained they are true and correct, except for those
13 matters not within my personal knowledge, and as to those matters, I believe them
14 to be true and correct. Further, the proffered evidence will support my allegations
15 made in my pleadings and papers on file herein.
16

17 ***I declare under penalty of perjury under the laws of the State of Nevada***
18 ***(NRS 53.045 and U.S.C. §1746, that the foregoing is true and correct.***
19



DECISION AND ORDER

This decision and order concerns Lisa Myer's counter motion to modify physical custody that was filed on October 12, 2020. The court considered the papers and pleadings, and the arguments of counsel at the hearing on August 31, 2021. The court concludes that the motion should be denied, and the matter should be closed. In support of this conclusion, the court finds:

1. This court has custody jurisdiction and personal jurisdiction over the parties to this case. This court has continuing exclusive custody jurisdiction over post-judgment custody matters pursuant to the UCCJEA as adopted in the Nevada Revised Statutes. Lisa Meyers resides in Clark County, Nevada. Caleb Haskins and the parties' minor child reside in Oregon.
2. Caleb Haskins filed a Complaint for Divorce on August 20, 2010, and Lisa Myers' Answer and Counterclaim was filed on October 5, 2010. The parties have one minor child, S.R.H., who was born on March 30, 2010.
3. The case was assigned to Department H on June 19, 2012. The court set a trial date, and the matter was decided after a non-jury trial on October 18, 2012, and October 22, 2012. The Decree of Divorce was filed on November 13, 2012.
4. Caleb Haskins has had primary physical custody of S.R.H., subject to Lisa Myers' visitation since 2012.
5. Caleb Haskins' motion to relocate with the child to Oregon was granted after an evidentiary hearing held on February 27, 2014.

1 6. Caleb Haskins has had primary physical custody in Oregon since 2014, and
2 the child has travelled to Nevada to visit Lisa Myers.
3

4 7. Lisa Myers has filed ten (10) appeals to the Nevada Supreme Court before
5 and after the divorce. Specifically:
6

7 a. Lisa Myers filed a Notice of Appeal (1) on February 23, 2010.
8

9 b. Lisa Myers filed a Notice of Appeal (2) on April 28, 2011.
10

11 c. Lisa Myers filed a Notice of Appeal (3) on June 13, 2011.
12

13 d. Lisa Myers filed a Notice of Appeal (4) on June 13, 2011.
14

15 e. Lisa Myers filed a Notice of Appeal (5) on April 12, 2012.
16

17 f. Lisa Myers filed a Notice of Appeal (6) on June 11, 2012.
18

19 g. Lisa Myers filed a Notice of Appeal (7) on September 5, 2012.
20

21 h. Lisa Myers filed a Notice of Appeal (8) on December 17, 2012.
22

23 i. Lisa Myers filed a Notice of Appeal (9) on December 18, 2012.
24

25 j. Lisa Myers filed a Notice of Appeal (10) on April 21, 2014.
26

27 8. The appeals have been dismissed by the Nevada Supreme Court.

- 1 9. This case was reopened by Caleb Haskins on September 21, 2020, when he
2 filed a motion to enforce the custody orders after Lisa Myers did not return
3 the child to him in August, 2020, after summer visitation in Nevada.
4
- 5 10. Lisa Myers filed an opposition and countermotion for a change in
6 physical custody on October 12, 2020.
7
- 8 11. The court heard this matter on October 14, 2020. The court ordered the
9 immediate return of the child to the custodial parent. The court filed a
10 Pick-Up Order on November 16, 2020, and the child was returned to Caleb
11 Haskins in Oregon.
12
- 13 12. The court allowed ninety days of post-judgment discovery to give the
14 parties an opportunity to persuade the court that there was adequate cause
15 to re-litigate physical custody. This period of limited discovery was
16 extended by the court, and by the parties' stipulation and order.
17
- 18 13. The court heard this matter on August 18, 2021. The court ordered final
19 briefing and set the matter for hearing on August 31, 2021. On that date,
20 the considered the papers on file, and the arguments of counsel. The matter
21 was taken under advisement.
22
- 23 14. Nevada statutes and case law provide that the district court has broad
24 discretion concerning child custody matters. *Rooney v. Rooney*, 109 Nev.
25 540, 853 P.2d 123 (1993).
26
27
28

1 15. The Nevada Supreme Court discussed the principles of res judicata as it
2 relates to a post-judgment request to change child custody orders in *Castle*
3 *v. Simmons*, 120 Nev. 98 (2004), and in *Martin v. Martin*, 120 Nev. 342
4 (2004). The doctrine of res judicata as applied through the changed
5 circumstances doctrine promotes finality and stability in child custody
6 cases.
7

8
9 16. The Nevada Supreme Court adopted an “adequate cause” standard,
10 holding that the district court has discretion to deny a motion to modify
11 custody without holding a hearing if the affidavits do not show a prima
12 facie basis for a change in custody. To constitute a prima facie case it
13 must be shown that (1) the facts alleged in the affidavits are relevant to
14 grounds for modification; and (2) the evidence is not merely cumulative or
15 impeaching. *Rooney v. Rooney*, 109 Nev. 540, 853 P.2d 123 (1993).
16
17

18 17. The Nevada Supreme Court applied and adopted the two-part test for
19 custody changes when one parent has primary physical custody. A
20 modification of primary physical custody is warranted only when (1) there
21 has been a substantial change in circumstances affecting the welfare of the
22 child, and (2) the child’s best interest is served by the modification. The
23 party seeking a modification of custody bears the burden of satisfying both
24 prongs. *Ellis v. Carucci*, 123 Nev. 145, 161 P.3d 239 (2007).
25

18. The court concludes that the countermotion filed by Lisa Myers and her supporting filings do not state facts that would support a substantial change in circumstances affecting the welfare of the child, and that the child's best interest is served by the modification. The countermotion lacks merit and should be denied.

Therefore,

IT IS HEREBY ORDERED that Lisa Myers' countermotion that was filed on October 12, 2020, is denied.

IT IS FURTHER ORDERED that the matter is closed upon the entry of this order.

(THE PROCEEDINGS BEGAN AT 11:05:15)

5 THE COURT: Okay. On page 1 of our 10:00 calendar,
6 we have the Haskins and Myers case, post judgment proceedings
7 on the D-2010-434495. Mr. Zernich, you're connected by
8 BlueJeans?

9

MR. ZERNICH: Yes, Your Honor, I am. Thank you.

10

THE COURT: And, Ms. Marr, are you connected by
11 BlueJeans?

12

MS. MARR: I am, Your Honor. Thank you.

13

THE COURT: All right. I appreciate you contacting
14 the Court. We understand that you were in another matter at
15 the beginning of the hour. So we are glad that both Counsel
16 are available.

17

MS. MARR: That's --

18

THE COURT: We just had a hearing a couple weeks
19 ago. This matter has actually been pending for, you know, the
20 better part of a year. The Court is going to be making a
21 decision as to whether we set an evidentiary proceeding, or
22 whether we determine that there's adequate cause to set one.

23

And I asked for you guys, since we had this period
24 of time for since the end of last year where we had discovery

1 that the Court allowed, and then those discovery deadlines
2 were extended by stipulation and order. I asked you to sort
3 of summarize everything with your filings and both of you have
4 done that.

5 The Court has had a chance to review your updated
6 papers including the papers that you filed, Ms. Marr, on the
7 27th of August. And I don't -- I don't have a lot of time on
8 this calendar. But I want you to be able to take a few
9 minutes to make your argument on the record. I know that
10 you've made your written arguments on more than one occasion.

11 But the Court is going to be taking this under and
12 issuing an order to determine whether the counter motion that
13 was filed last, I think it was October or September, whether
14 there's adequate cause to set an evidentiary proceeding on
15 Mom's request for change of custody.

16 So the way -- that's the way I'm going to approach
17 it. Mr. Zernich, I'm going to let Ms. Marr make her pitch for
18 the Court exercising discretion to set an evidentiary
19 proceeding. And then you'll state your position in
20 opposition.

21 You know, in this particular case, I mean, I --
22 there was a long period of time between the time that the
23 Court heard it. I think between 2014 and 2020 I had heard it
24 just once in 2018, and that was on a motion that I denied at

1 that time for the same, you know, I didn't find adequate cause
2 to re-litigate custody in '18.

3 So frankly, with the failure to return the child
4 last fall and then the order to have the child returned, and
5 then the motion and the counter motion and the other filings,
6 I wasn't sure whether there was adequate cause to re-litigate
7 the issue of custody. There's a lot of baggage in this case.
8 So I allowed the discovery period of time to see if facts
9 could be developed with the use of discovery to support a
10 prima facie case.

11 I mean, we know that Dad's had physical custody, so
12 Mom would have to make a prima facie case for changes in
13 circumstance and best interest. And you know, the Court
14 hadn't committed one way or another whether to have a hearing.
15 In my mind, I thought that this would be resolved and the case
16 would be closed, or we'd have a hearing months ago in the
17 spring.

18 But we're not getting around to it 'til now. So I
19 know you took the time to lay it all out in your filing on the
20 27th. What do you want to add, Ms. Marr?

21 MS. MARR: Your Honor, and I appreciate your kind
22 words. I put forth the argument the best I could in writing,
23 and I won't take too much of the Court's time because I
24 believe that we've submitted everything to the extent we were

1 able to. And I know that these matters aren't taken lightly
2 when there's somebody has primary physical custody.

3 And I've read Ellis v. Carucci as we all have, and
4 recognize the need for stability in a child's life, or
5 children's lives. With that being said, this is a child, and
6 I've seen things, some -- I'll make an offer of proof to the
7 Court that I've seen some communications subsequent to the
8 close of discovery between the parties in this case. And it
9 just solidified what -- what I put forth before the Court.

10 There's frustration of my client, Lisa Myers',
11 ability to co-parent. But probably most moving is the -- a
12 video wherein the child, at the prospect of returning to
13 primary physical custodian is actually physically sick. And
14 again, that's an offer of proof.

15 But this is a case, a sad case. But it -- and we're
16 supposed to consider the best interest of the child. Of
17 course we don't let children dictate where they want to be
18 simply because it would be fun or there won't be any -- any
19 discipline.

20 But that's not the case here, Your Honor. In
21 addition to -- we'll take it two prongs, the first being is
22 there's substantial change in circumstances affecting the
23 welfare of this child, absolutely. And unfortunately, there's
24 -- based on the lack of frustration and the -- or the lack of

1 co-parenting and the frustration and anger and the living
2 conditions that the child is in right now, and I'm not talking
3 about one parent may have more money or anything like that.

4 I'm talking about actual living conditions, the
5 people who are in the household, what the child is subjected
6 to, if there's DV in the household from -- from another --
7 another -- somebody else, a third person who's not a party to
8 this case. Yes, her life has changed. That coupled with the
9 fact that there's an abundance of opportunity that this child
10 could be given here in Las Vegas with Mom.

11 And it's not a fin -- it's not nearly a financial
12 opportunity. It's a -- it's a chance for her to grow and to
13 blossom into the young lady that she deserves. She deserves
14 that. And again, I can't emphasize enough, Your Honor, this
15 isn't about oh, you know, it's going to be fairytale life and
16 that's why we should change custody. We certainly don't do
17 that.

18 First and foremost, it's based upon the living
19 conditions. And even the refusal, this hostility towards Mom,
20 I can't understand it at the expense of the child. Her teeth
21 are one example. I -- I couldn't imagine not being able to
22 eat without pain. I couldn't imagine a father that wouldn't
23 talk to my brother for my well-being. I couldn't imagine a
24 world like that, Your Honor.

1 And so, yes, her living conditions are -- well,
2 there has been a change in circumstances. And I'm -- I'm
3 sorry that we got to this point, but here we are. And I know
4 Mom's committed to making the best -- and again, I'll make an
5 offer of proof. I've read the communications between the
6 parties, and it's always this negative, hostile response from
7 Dad. And irrespective of whatever that issue may be, this is
8 about the child and this is about giving her every opportunity
9 that's affordable to her.

10 THE COURT: All right. And if you had a hearing,
11 other than the parties, would -- who would you call?

12 MS. MARR: I would call the child's psychologist
13 that she's currently in school with. I would call Charity
14 Haskins because she's had an opportunity to observe a lot of
15 what's happening out of state. And it is unfortunate.

16 And offhand, I don't have my list available, Your
17 Honor, but I would certainly call the parties themselves. And
18 I would -- I'm trying to be as succinct and efficient as I
19 could at the time of evidentiary hearing because as this Court
20 has already stated, this has been going on for too long, and
21 this child needs resolution.

22 THE COURT: Okay. Mr. Zernich, briefly, please?

23 MR. ZERNICH: Yeah. Thank you, Your Honor. I have
24 to say that there's a reference that this case is a sad, sad

1 case. I'm going to have to say I think that the only sad
2 thing that this case is about the money that my client is
3 spending to show that Mom has no case.

4 The mom won't look at the evidence, and continues to
5 pursue this case with evidence that directly contradicts her
6 claims, that we would talk about negative or hostile
7 responses, that they tend to go both ways. And if they're
8 coming from Dad, then the Court should consider why. And it's
9 because Mom keeps bringing false claims.

10 I think we're here about the sufficiency of the
11 evidence, and there's been a lot of documents that have been
12 produced. But meanwhile, the brief about the sufficiency of
13 the evidence is nothing but a rehash of the motion. It
14 doesn't address any of the documents that were received, but
15 we keep hearing that we've seen the emails and that we're
16 going to call the witnesses, but -- but nothing to show that
17 there's any evidence whatsoever except for my client has
18 produced to show that Mom's claims are false.

19 I'm going to go through them pretty quickly. They
20 say that he withheld returning the child at the end of the
21 spring break. But Bates number 3 has emails between the two
22 of them that state otherwise. She -- he suggested he keep an
23 extra week and give a week of makeup in the summer. She
24 responds I appreciate your email and your concerns, and offer

1 an additional week during summer break with Sydney, we'll
2 agree to allow her to remain with you at your home, in
3 whatever town that is in Oregon, due to the concerns of the
4 coronavirus.

5 What is it about this that someone can't read and
6 continues to say that he withheld when she agreed? Why are we
7 even continuing this charade?

8 Okay. The DFS report, they claim that DFS
9 investigated and they found problems. We produced that. It
10 was produced in discovery, number -- page number 24. This
11 referral is unfounded in threat of harm or neglect to Sydney
12 Myers Haskins by her father Caleb and his wife Valerie. I
13 could read more, but that's essentially it. Right?

14 They keep talking about the teeth, and that the
15 teeth lead to two things. She's in pain so she can't eat.
16 She can't eat so she's underweight and what a horrible
17 condition. However, we produced pediatrician records of six
18 visits since April of 2018. If you look at page number 59, if
19 we look at every single -- every single one of them, but I
20 could point out the pages really quick.

21 Number 59, January 5th, 2021. Well nourished, well
22 kept. Underneath there, generally healthy 10-year-old with
23 some mild anxiety. All right. Then we go on to number 61
24 which is from 10/23/2019. General appearance, patient is well

1 developed and well nourished, sitting in the clinic chair
2 answering questions appropriately.

3 Then we go on to number 63. All right. June 12,
4 2019. General health -- generally constitutional healthy
5 appearing. Orientation alert, and oriented to person, place
6 and time. Mood and affect appropriate. Then we look at the
7 next one which is number 64 from April of 2018, generally
8 healthy, appearing well nourished. No acute distress.

9 Then we look at the next one on page number 70.
10 Right? Page number 70 shows that there has been six visits to
11 the doctor. Right? So then let's go to the -- to the dental
12 records because they're produced also. At page number 73 will
13 show you that -- cc means chief complaint. All right. This
14 is the dental records.

15 June 5th, 2019, chief complaint, none. December
16 11th, 2019, chief complaint, none. June 2nd, 2020, chief
17 complaint, none. December 8th, 2020, chief complaint, none.
18 She's not complaining about the teeth that they keep saying
19 she's having. Mom is telling that to the Court because she
20 wants a case. Right?

21 However, Mom took the child to the orthodontist. By
22 the way, against Court orders because she's not supposed to be
23 doing that. I believe that there was some legal custody
24 orders that change and said she's not supposed to be taking

1 the child to the doctor for some stuff prior to me being here.

2 And her own -- in her own orthodontist records,
3 let's look at page number 82, 83, and 84, and 86. Her own
4 orthodontist records. Well, my client got -- my client got a
5 follow up. He emailed the orthodontist. The follow up email
6 says general orthodontic consultation. Doctor Allison Tomon
7 (ph) recommended we wait six months to reevaluate and give
8 Sydney some time to grow, and lose some baby teeth, as well.

9 All right. The next page says behavior, good. No
10 treatment at this time. Doctor recommended flossing and
11 demonstrated on the teeth. Then we got the cc on the -- on
12 the next page. Patient presented with Mom (indiscernible)
13 reviewed, yes. Parental consent obtained. Chief complaint,
14 checkup. Nothing about pain. Last page. Waiting on primary
15 teeth to fall out.

16 Your Honor, I thought that discovery was opened to
17 give Mom a bit of a chance to -- to find information about her
18 allegations. It was somewhat of a fishing expedition, but
19 that's the Court's choice. We've been doing this a long time.
20 We've produced tons of documents. There's been no motions
21 into the discovery commission to say that he failed to produce
22 adequate documents.

23 And then we come back to have a sufficiency review,
24 and the only sufficiency review does is support my client's

1 case. I think the Court should shut this down right now and
2 allow us to present the fees and costs so we could recoup some
3 of the money that he's spending. That's it. Thank you for
4 the time.

5 THE COURT: All right. Good. I appreciate your
6 efforts, Counsel. I'm satisfied that, you know, that when we
7 had our hearing on the 18th, you did what I needed you to do
8 which was to try to tie up all the loose ends that would
9 explain why this matter might have been pending for -- since
10 September or October of last year.

11 And the Court is -- really needs to review the
12 record, the pleadings, the papers, and your arguments and
13 issue a written order, which I'll do as soon as I can. So the
14 matter is taken under advisement, and I'll try to get a
15 decision out this week.

16 MS. MARR: Thank you, Your Honor. May I -- may I
17 say one thing? The records that were produced, the exhibits
18 by Mr. Haskins are different from the records that were
19 produced during discovery, which are voluminous. So I haven't
20 -- I've been in trial. I haven't had an opportunity to
21 determine whether the records that he produced this last go
22 around after the close of discovery are identical. At first
23 blush, it appears not.

24 But in any event, we're confident and I would just

1 make one final offer of proof is that we have witnesses. The
2 last time I knew, I had -- actually had a federal judge tell
3 me one time who was concerned about a summary judgment motion,
4 Ms. Marr, what somebody testifies to is still evidence. So
5 I'll just leave it at that.

6 THE COURT: Thank you very much.

7 MS. MARR: And we do have witnesses.

8 THE COURT: All right. You can log off, hit the red
9 button so I can move on to another case. Thank you.
