



**ORDER DENYING REQUEST FOR
SUMMARY DISPOSITION OF PETITION
FOR CHANGE OF NAME**

On June 22, 2021, Mr. Robinson filed a Petition for Name Change. On Page 2, he states that he has been convicted of a felony on 8/19/2019 in Clark County, Nevada for Home Invasion.

NRS 41.270 states, in relevant part, that "if the applicant has a criminal record, the petition must be accompanied by a complete set of the applicant's fingerprints taken in the manner prescribed by the Director of the Department of Public Safety." Any person applying for a name change who has been convicted of a felony must get fingerprinted and submit those fingerprints to the Court with the name change form. If the name change is granted, the court will submit a copy of the name change order to the Central Repository for Nevada Records of Criminal History for inclusion in the applicant's criminal record.

Mr. Robinson did not include a copy of his fingerprints with the rest of his paperwork. The Department of Public Safety website, found at dps.nv.gov, can provide further direction on how to get fingerprinted as required by Nevada law.



Pursuant to NRS 41.270 stated herein in relevant part "that if an

a complete Set of FingerPrints in the Manner described by the Director
of Public Safety". Due to this statute, the Petitioner's own admission on his
application and Petitioner's failure to have Submitted the required FingerPrints
for adjudication on the Matter. The Court entered an Order of Denial on
