
ORDER

Appellant has filed a letter seeking information regarding his appeals. Appellant currently has appeals pending in Docket Nos. 83773, 83774, 83841, 83952, and 83956. The appeals in 83773 and 83841 are from

appellant's challenge of the October 19, 2021, order denying his postconviction habeas petition in district court cases 2018-CR-00084B and 2018-CR-00116B. These appeals shall be consolidated for all appellate purposes. NRAP 3(b)(2). The appeal in 83774 is from appellant's challenge of the district court's October 15, 2021, order denying his postconviction petition requesting genetic marker analysis in 2018-CR-00084B. And the appeals in 83952 and 83956 are from appellant's challenge of the district court's November 10, 2021, order denying his motion to vacate sentence in 2018-CR-00084B and 2018-CR-00116B. These appeals shall be consolidated for all appellate purposes. *Id.* A copy of the first page of appellant's notices of appeal are attached to this order.

Appellant has filed his informal brief in Docket No. 83774. The exhibits attached to the brief were returned, unfiled. NRAP 30(i) ("A pro se party shall not file an appendix except as otherwise provided in these Rules or ordered by the court."). Appellant's opening brief or informal brief in 83773 and 83841 is due to be filed on or before April 12, 2022, and the opening brief or informal brief in 83952 and 83956 is due to be filed on or before May 10, 2022.
