
*ORDER GRANTING MOTIONS*

180 Land Co., LLC and Fore Stars Ltd have filed an unopposed motion to file volume 130 of the joint appendix under seal on the ground that the volume contains confidential documents sealed by the district court. The motion is granted. SRCR 3(4)(b) and (h). The clerk of this court shall file under seal the paper copy of Volume 130 of the joint appendix received on October 27, 2022.

Proposed amicus City of Reno has filed a motion for an extension of time to file an amicus brief in support of appellant and respondent/cross-appellant City of Las Vegas. The motion is opposed. Proposed amicus International Municipal Lawyers Association has filed a motion for leave to file an amicus brief in conjunction with City of Reno and

City of North Las Vegas. Proposed amici have submitted an amicus brief for filing. NRAP 29 permits a political subdivision of the state to file an amicus brief without leave of the court. NRAP 29(a). Having considered the motions and opposition, both motions are granted. NRAP 29(f); NRAP 26(b)(1)(A). The clerk of this court shall detach the amicus brief from the motion filed by International Municipal Lawyers Association and shall file it separately. *See* NRAP 29(a).
