The City of Henderson hereby joins the "BRIEF OF AMICI CURIAE CITY OF RENO, CITY OF NORTH LAS VEGAS, AND INTERNATIONAL MUNICIPAL LAWYER'S ASSOCIATION IN SUPPORT OF APPELLANT," (22-33948) (referred to here as the "Municipalities' Brief") filed in this appellate proceeding by the City of Reno, City of North Las Vegas and the International Municipal Lawyer's Association (collectively the "Municipalities") on December 5, 2022.

The City of Henderson concurs with the positions which the Municipalities have set forth in the Municipalities' Brief. The following matters set forth in the Municipalities' Brief are of critical importance to the City of Henderson and are essential for conducting one of its core functions—land use regulation. The City joins the Municipalities in the following arguments:

- The denial of the petition for judicial review in this matter should have been determinative of any alleged vested property rights and precluded a taking's claim. See Municipalities' Brief at p. 5.
- There is no vested right to develop, and no bases for a taking,
 where the governing body denies a project that complies with

zoning but violates the general plan. More simply put - a Zoning designation alone does confer a vested right to develop. See Municipalities' Brief at pp. 8-22.

- A takings claim cannot be based on the denial of a single application and where alternative economic uses are available. See Municipalities' Brief at pp. 22-28.
- There can be no taking's claim where a landowner deprives the government body of the opportunity to properly consider a land use request by failing to properly complete the application process. Again, simply stated where an application is not completed, no application is made, and the governing body cannot make a final decision. Without a final decision, there can be no taking. See Municipalities' Brief at pp. 28-30.
