
*ORDER ESTABLISHING COMMISSION TO

AND LICENSING OF ATTORNEYS*


Pursuant to the Nevada Rules on the Administrative Docket, and in response to requests to review the current processes for the licensing of attorneys within the State of Nevada, we hereby create a study committee known as the Bar Licensing Commission. The Commission shall conduct hearings and study the issues and concerns arising from the methodology and administration of the Bar examination and the licensing procedures for attorneys within the State of Nevada.

Further, the individuals listed on Exhibit A are hereby appointed as members of the Bar Licensing Commission and Richard M. Trachok, II, shall serve as chair of the Commission. The method and approach for the Commission's investigations shall be determined by the

Commission. The Commission shall file a report with this court on its findings and recommendations no later than September 30, 2022.
