17 In the instant matter, a jury trial was held, and on February 10, 2022, the jury found the Appellant
18 guilty of Battery With Use of a Deadly Weapon Resulting in Substantial Bodily Harm. On February 17,
19 2022, the Appellant was sentenced under the large habitual criminal statute to life with a minimum parole
20 eligibility of ten years in the Nevada Department of Corrections with five hundred forty days credit for time
21 served to run consecutive to the other charges in the Appellant's first trial. The Amended Judgment of
22 Conviction was entered on March 8, 2022, and this appeal followed.
