1           **RESULT IN THE DISTRICT COURT:** That based on the Findings of  
2 Fact, Conclusions of Law and Decision of the District Court, neither party was the  
3 prevailing party, as the orders were neutral.

4           **TYPE OF ORDER BEING APPEALED:** An order regarding separate  
5 assets; an order regarding community waste; a custody order; and a child support  
6 order.

7           **RELIEF GRANTED BY THE DISTRICT COURT:**

- 8           a. The Court divided the equity in the marital residence equally between  
9           the parties, despite making a finding that it was separate property of  
10           the appellant;  
11           b. The Court denied Appellant/Plaintiff's request for recovery of  
12           community funds wasted by Respondent/Defendant;  
13           c. The Court awarded joint physical custody to the parties;  
14           d. The Court ordered that no child support shall be paid.


