*ORDER CREATING COMMITTEE TO STUDY  
THE RULES GOVERNING ALTERNATIVE DISPUTE RESOLUTION  
AND NEVADA SHORT TRIAL RULES*

On March 24, 2022, Ron D. Parraguirre, Chief Justice of the Nevada Supreme Court, filed a petition seeking to create a Committee to Study the Rules Governing Alternative Dispute Resolution and Nevada Short Trial Rules to consider and make recommendations for comprehensive amendments to the Rules.


Having considered the petition, we conclude that such a committee should be created. The Committee shall conduct all hearings in public and post all meeting minutes and documents considered by the Committee on the Supreme Court's website.




