**RESPONDENTS' JOINT MOTION TO STRIKE APPENDIX TO  
EXCLUDE MATTERS OUTSIDE THE RECORD ON APPEAL**

## MEMORANDUM OF POINTS AND AUTHORITIES

Respondents, Brian Chiesi, Debora Chiesi, Quicken Loans Inc. (together with the Chiesis, “the Chiesi Respondents”), Joel A. Stokes, individually, Joel A. Stokes and Sandra F. Stokes, as Trustees of the Jimijack Irrevocable Trust, Jimijack Irrevocable Trust; Red Rock Financial Services; and Nationstar Mortgage LLC, by and through their respective counsel of record, hereby move to strike those portions of Appellant’s Appendix that include matters outside the record of appeal.

### I. STATEMENT OF FACTS

As early as June 22, 2021, counsel for the Chiesi Respondents attempted to comply with NRAP 30(a) by contacting counsel for Appellant Nona Tobin (“Tobin”) with respect to a Joint Appendix. See e-mail dated June 22, 2021, attached hereto as **Exhibit 1**. Efforts to comply with NRAP 30(a) continued through July, August, and September, during the time period in which Tobin obtained four extensions to file an Opening Brief and Appendix. See September 23, 2021 e-mail, with attachments of prior communications, attached hereto as **Exhibit 2**.

On August 24, 2021, Tobin’s counsel provided the first draft of the proposed Appendix to Respondents’ counsel for review and comment. Id. at p. 5. By e-mail of the same date, counsel for the Chiesi Respondents objected, noting that the proposed Appendix included substantial filings that were not in the district court record in violation of NRAP 10(a). Id. at p.2-4. On August 25, 2021, counsel for the Chiesi

Respondents provided a proposed redline draft of the Appendix, requesting the removal of all items that were not part of the record on appeal. Id. at p.2, and pp.8-30.

On September 23, 2021, counsel for the Chiesi Respondents e-mailed Tobin's counsel requesting confirmation as to whether Tobin would incorporate the substantial revisions provided on August 25, 2021. Tobin's counsel did not respond to the September 23, 2021 e-mail, and instead filed numerous volumes of a proposed appendix that were later stricken by the Clerk of Court *sua sponte* for failure to comply with NRAP 30. See Notice of Deficient Appendix. Following the Court's Notice of Deficient Appendix, Tobin filed a twenty-two volume Appendix that likewise failed to comply with NRAP 30.

Respondents jointly move to strike Volumes 1-15, and items 1, 2, 3, 4, 5, 7, and 8 of Volume 16, as said filings are not part of the record on appeal. Volume 16, item 3 is misidentified. The identified filing ends at AA3140; however, the Tobin Declaration included in item 3 (AA3141-3154) is likewise not a part of the record on appeal and should be stricken. The Appendix is also missing Nationstar's Joinder, which is part of the record on appeal. Nationstar reserves the right to file a supplemental Appendix to include the Joinder. Finally, Volume 21, item 5 misidentifies the filing and Volume 22 includes several duplicate filings.

## II. ARGUMENT

NRAP 10(b) limits the Record on Appeal to:

(1) The Appendix. For the purposes of appeal, the parties shall submit to the clerk of the Supreme Court ***copies of the portions of the trial court record to be used on appeal***, including all transcripts necessary to the Supreme Court's or Court of Appeals' review, as appendices to their briefs. Under Rule 30(a), a joint appendix is preferred. This Rule does not apply to pro se parties. The Supreme Court or Court of Appeals will determine whether its review of the complete record is necessary in a pro se appeal and direct the district court clerk to transmit the record as provided in Rule 11(a)(2).

(2) Exhibits. If exhibits cannot be copied to be included in the appendix, the parties may request transmittal of the original exhibits to the clerk of the Supreme Court under Rule 30(d).

(emphasis added). “Matters outside the record on appeal may not be considered by an appellate court.” Hooper v. State, 95 Nev. 924, 926, 604 P.2d 115, 116 (1979); NRAP 10(a) (“trial court record consists of the papers and exhibits filed in the district court”). When a party to an appeal includes documents that are not part of the district court record, matters outside the record will be stricken. See Kelly v. Tahoe Regional Agency, 109 Nev. 638, n.18, 855 P.2d 1027, n.18 (Nev. 1993) citing Goldman v. Nevada Comm'n on Judicial Discipline, 108 Nev. 251, 272 n.20, 830 P.2d 107, 121 n.20 (Nev. 1992) (granting Respondent's Motion to Strike to exclude public records that were not filed with the District Court); Grey v. Grey, 111 Nev. 388, 390 n.1, 892 P.2d 595, 597 (Nev. 1995).

Here, Volumes 1-15, and Volume 16 items 1, 2, 3, 4, 5, 7, and 8 (the “Prior Case Filings”) are not part of the record on appeal and therefore may not be considered by this Court. Hooper v. State, 95 Nev. 924, 926, 604 P.2d 115, 116 (1979). The Prior Case Filings were filed in a separate action involving various parties to this appeal, but they were not filed in the district court action which is the subject of this appeal. While some of the Prior Case Filings are properly included in the record on appeal to the extent the filings were part of the Chiesi Respondents’ Request for Judicial Notice (see Volumes 19 and 20, AA3813-4241), the Prior Case Filings that were not filed with the district court in Case No. A-19-799890-C must be excluded. Accordingly, Respondents request that this Court strike Volumes 1-15 and Volume 16 items 1, 2, 3, 4, 5, 7, and 8.

Hi Brittany,

In order for the court to determine whether or not claim and issue preclusion apply to the complaint dismissed, it must evaluate the first action as well as the second action. That is why I included the record from the first action that the defendants represented/argued was already actually litigated. The comparison between the two cases is crucial to the analysis of claim and issue preclusion, upon which the defendants based their Motion to Dismiss, which was granted by the court.

"Among other requirements, for [claim] preclusion to attach ... 'the subsequent action [must be] based on the same claims or any part of them that were or could have been brought in the first case.' " Id. (third alteration in original) (quoting Five Star Capital Corp. v. Ruby, 124 Nev. 1048, 1054–55, 194 P.3d 709, 713 (2008)). For "issue preclusion to attach, the issue decided in the prior [proceeding] must be identical to the issue presented in the current [proceeding]," id. (alterations in original) (quotation omitted), and have been " 'actually litigated and determined by a valid and final judgment [in which] the determination [was] essential to the judgment.' " In re Sandoval, 126 Nev. —, —, 232 P.3d 422, 424 (2010) (quoting Restatement (Second) of Judgments § 27 (1982)).
