STATEMENT OF FACTS

On 2-11-21 I appeared pro se in RJC courtroom NB heard by Tierra Jones for writ of habeas corpus for JAC. On 3-4-21 the court entered a decision denying my petition for post conviction relief and motion for appointment of counsel. On 3-29-21 I filed a notice of appeal to the supreme court again as a pro se litigant to meet the 4-12-21 deadline. On 4-6-21 I received notice of the entire record on appeal being submitted to the supreme court pursuant to their order. On 4-27-21 I retained an attorney by proxy from AMD Law by the name of Alexis M. Duecker. Between 3-18-21 and 8-3-21 I had telephonic communication and correspondence with Mrs. Duecker regarding the briefing schedule, received receipts of remittance for services and future plans of action moving forward. On 8-6-21 I received notice from AMD Law of impromptu interruption in services due to an undisclosed personal matter concerning the Covid-19 pandemic with guarantee to refund the entirety of remittments thus far within 7-10 calendar days, including information conducive to my proceeding pro se as my 8-18-21 deadline was rapidly approaching. On 8-9-21 I called the clerk of supreme court requesting and receiving a telephonic extension of 14 days. I am requesting this extension due to the exigent, unforeseen and absolutely unpredictable circumstances concerning the covid-19 pandemic, institutional restrictions, covid-19 protocol with work schedule and extremely limited law library access as I am forced and compelled to proceed pro se subsequent to operating under the knowledge of having legal representation.

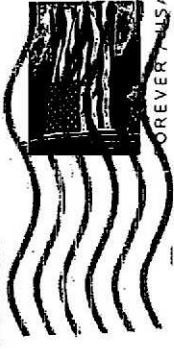
