



Kevin Pasquale, Chief Deputy District Attorney, present on behalf of the State. Marni Pool, present (via Zoom) on behalf of the Division of Parole and Probation. Defendant, present (in custody via Zoom), with counsel Matt Stermitz, Humboldt County Public Defender. Denni Byrd, Pre-Trial Services Coordinator, also present.

The record reflected that this matter comes before the Court for sentencing.

The Court informed the Defendant of the purpose of the hearing.

The Defendant stated his understanding.

The Defendant had previously pled GUILTY to the charge of POSSESSION OF A CONTROLLED SUBSTANCE, a Category E Felony, in violation of NRS 453.336. Copies of the Pre-Sentence Investigation Report had been received and the Defendant provided factual corrections. The Court added today's date for sentencing on the PSI Report.

The Court ordered the Defendant to go back into custody and ordered to revoke his own recognizance and would reschedule a continued arraignment in the next law and motion day.
