I. INTRODUCTION

Petitioner, Minh Luong, by and through her attorney, Marshal S. Willick, Esq., of the Willick Law Group, and pursuant to NRAP 27(d)(2), moves this Court for permission to file her *Emergency Petition for Writ of Mandamus or Prohibition per NRAP 21(a)(6) and NRAP 27(e)*” in excess of 7,000 words under the type/volume limits based upon the below Points and Authorities.

POINTS AND AUTHORITIES
