

11 **WHEREAS SCR 98(5) states:**

12 *Any member of the state bar who is not actively engaged in the practice of law in*
13 *this state, upon written application on a form approved by the state bar, may resign*
14 *from membership in the state bar if the member: (a) has no discipline, fee dispute*
15 *arbitration, or clients' security fund matters pending and (b) is current on all*
16 *membership fee payments and other financial commitments relating to the*
member's practice of law in Nevada. Such resignation shall become effective when
filed with the state bar, accepted by the board of governors, and approved by the
supreme court.

17 **Attorney Paula Bauer, Bar Number 5868, submits this application requesting**
