Appellant Amanda and Respondent Alfredo met as students at Liberty High 9 10 School in 2004, and dated until 2006. Amanda became pregnant by a man named 11 Tyrell Johnson in 2011. Several months into the pregnancy, Amanda and Alfredo 12 reconnected. Two years after the child Ricardo was born, Alfredo suggested the 13 14 idea of adding his name to the child's birth certificate, in spite of the fact that the 15 biological father had neither been notified nor his parental rights terminated. 16 Amanda agreed to this idea and the parties carried out the process, with both 17 signing a Voluntary Acknowledgment of Paternity asserting that Alfredo was the 18 19 only possible biological father of Ricardo. At no point has Alfredo believed he was 20 the biological father of Ricardo. 21

In 2014, the parties' romantic relationship ceased, though Amanda continued
to allow Alfredo to see Ricardo.

biologically his. Thereafter, respondent refused to return the minor child to appellant. On June 3<sup>rd</sup>, 2019, appellant filed a Motion for a Pickup Order. At the consequential Hearing on June 13<sup>th</sup>, 2019, Respondent's counsel admitted that Alfredo was not the biological father. On August 12th, 2019, Appellant filed a Motion to Dismiss for Failure to Join a Necessary Party and Motion for Summary Judgment and Related Relief. On October 24<sup>th</sup>, 2019, Appellant brought forth a Motion requesting summary judgment and to dismiss for failure to join a necessary party. Department G's district court judge denied the Motion without oral argument. The district court judge stated that "the statute is very clear" and that once a party's name is on the birth certificate and "they've followed the statutes and the time has run, the only way to remove their name from a birth certificate is by termination of parental rights..." The district court judge further stated that "we don't have that here" and "this is long established law." On November 22<sup>nd</sup>, 2019, Department G's district court judge issued an Order in case # D-19-590131-C, which found that Alfredo Medellin is the legal father of Ricardo. On December 3<sup>rd</sup> 2019, Department G's district court judge denied Appellant's Ex-Parte Request, which had been filed on November 18th, 2019. The Request was


