The Constable's Office seized cash from the dispensary, which cash belongs to Appellant. The district court denied the Application/Petition Pursuant to NRS 31.070(5) because the court determined the Appellant failed to comply with the requirements under NRS 31.070 and failed to establish that it has any relationship with or interest in the judgment debtor or the cash seized. The clear evidence before the court confirmed Appellant's compliance with NRS 31.070 and its interest in the cash seized. Appellant's relationship with the judgment debtor is immaterial.
