9 S.C.R. 98(5)(a) states:

10 Any member of the state bar who is not actively engaged in the
11 practice of law in this state, upon written application on a
12 form approved by the state bar, may resign from
13 membership in the state bar if the member: (1) has no
14 discipline, fee dispute arbitration, or clients' security
15 fund matters pending and (2) is current on all
16 membership fee payments and other financial
17 commitments relating to the member's practice of law in
18 Nevada. Such resignation shall become effective when
19 filed with the state bar, accepted by the board of
20 governors, and approved by the Supreme Court.

WHEREAS:

(1) Attorney Kurt Weinrich, Bar Number 5818, submitted an application requesting resignation from membership in the State Bar of Nevada and relinquishing the right to practice law in this state in accordance with S.C.R. 98(5)(a) (See Attachment 1); and


1 law in Nevada as evidenced by Exhibits A-D to Applicant's original application

SCR 98(5) APPLICATION FOR RESIGNATION

WHEREAS SCR 98(5) states:

Any member of the state bar who is not actively engaged in the practice of law in this state, upon written application on a form approved by the state bar, may resign from membership in the state bar if the member: (a) has no discipline, fee dispute arbitration, or clients' security fund matters pending and (b) is current on all membership fee payments and other financial commitments relating to the member's practice of law in Nevada. Such resignation shall become effective when filed with the state bar, accepted by the board of governors, and approved by the supreme court.

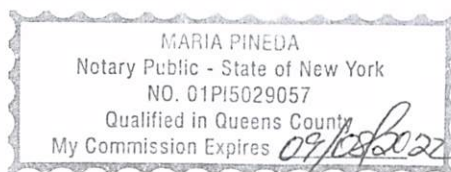
