MOTION FOR LEAVE TO FILE A RESPONSE TO THE PROBATE AND TRUST SECTION OF THE STATE BAR OF NEVADA'S MOTION FOR LEAVE TO FILE AMICUS CURIAE BRIEF UNDER NRAP 29(C)

Kathleen June Jones ("June" or "Appellant"), Appellant, by and through counsel, Barbara Buckley, Esq., Scott Cardenas, Esq., and Elizabeth Mikesell, Esq., of Legal Aid Center Of Southern Nevada, Inc., respectfully move this Court, pursuant to NRAP 27 and NRAP 29(f) for leave to file a Response to the Probate and Trust Section of the State Bar of Nevada's Motion for Leave to File Amicus Curiae Brief Under NRAP 29(c).

NRAP 29(f) provides that in granting leave for a later filing of the motion for leave to file an amicus brief, the court may specify "the time within which an opposing party may answer." Moreover, because the Section asked for lengthy extensions that placed the due date for their motion well after the time that briefing was completed, June must now request leave to file a response to their motion to file an amicus brief. At the time that the Section asked for extensions, it was not clear yet whether the State Bar of Nevada Board of Governor's would even approve the amicus brief. Thus, the need to now request leave to file a response was not due to any delay on June's part.

The State Bar of Nevada Board of Governor's vote took place on January 19, 2023, and June's counsel was informed on January 20, 2023 that the Board of Governor's approved the Section's request to file an amicus brief. Because the amicus brief discusses issues entirely separate from those on appeal and makes several ad hominem attacks against June's counsel, leave is now being requested to file a response to the motion for leave to file an amicus brief. For the sake of expediting this matter, June has attached to this motion her Response to the Probate and Trust Section of the State Bar of Nevada's Motion for

Leave to File Amicus Curiae Brief Under NRAP 29(c). See Response attached hereto as Exhibit 1. June should have an opportunity to respond to the Section's request to get involved as an amicus curiae, especially considering that the Section makes several consequential arguments that are irrelevant to the issues in this appeal.

This motion is submitted in good faith and for good cause shown. For the foregoing reasons, Appellant respectfully requests leave to file her Response to the Probate and Trust Section of the State Bar of Nevada's Motion for Leave to File Amicus Brief Under NRAP 29(c).
