Today, I received the 'receipt for documents' (Supreme Court No. 84783 / Dist. No. 22-0C 00060 (B)) and related filing packet (May 27, 2022) and forms. I believe it's necessary to be sure you are aware that this appeal stems from a denial of a 'request for submission' for a required "Court's Order out of First Judicial District Court" attached to (Supreme Court Case No. 84693) a In Proper Person - 'Writ of Mandamus' (see Chad Windham Mitchell v. First Judicial District Court) that is currently in your office. Your office had notified me of "Potential Dismissal" issues including "no paid filing fees" and "Proof of Service" requirements. I responded to those issues - but have no response yet.

The same issues plague me with ANY FILINGS, in any Court without the "Court's Order" in the exact 'Writ of Mandamus' sought then and still. Without that order - at least in part - I CAN NOT meet "PROOF OF SERVICE" or pay (even if funds were available) "FEES FOR SERVICES" (legal or other) from this facility. If you will view the content of the 'Writ of Mandamus' you will see the Carson City Sheriff's Office forces deficiency on me via multiple layers of operational procedures, at no fault of mine.

I CAN NOT EVEN GET "LEGAL COPIES" TO MAKE A DUPLICATE FILING TO SERVICE WITH - if I was allowed to receive more than one envelope (per indigent allowance) each week or pay "postage overages", which I am not without court order - see Jail Rules Handbook.

I'm requesting your office's input against the backdrop of absolute denial of legal by custody - the 'Writ of Mandamus' was/is my remedy to the restrictions I struggle against. (As I do not even have access to 'NRAP' to know what to adhere to and be forced to fail at to even send this appeal to the Court Clerks' Office, let alone meet 'proof of service'. This jail

gives no available access to legal filing (9x12 or up) size envelopes - even through commissary. (All access is through court's order.)

This whole scenario limits my ability to meet any expectation, because of no court order specifically required by jail procedures, which allows the jail to deny me adequate "Legal" as an absolute unless a specific court grants me forgiveness.

Please respond with the options available to me to succeed in entering a valid appeal packet to your Court. I Do NOT even have secure "legal mail" to Courts. (see Writ of Mandamus context) Please inform at soonest possible time. (Mail sometimes takes up to a week to be delivered coming in.) Thank you for your attention to my position. (Be aware, if you disbelieve my statements or seek validation for my statements - please seek access to my "Cobra Resident Kiosk Request/Communications" (electronic requests and complaints) within the Carson City Jail.) I do not exaggerate my conditions.
