**ORDER ACKNOWLEDGING REQUEST FOR SUBMISSION**

A Request for Submission was filed on June 28, 2022, submitting Ms. Fletcher's Motion for Leave to Proceed on Appeal In Forma Pauperis filed on June 1, 2022 and Reply to Opposition of Leave to Proceed IFP filed on June 28, 2022, to the Court for decision. Prior to that date, on June 8, 2022, the Nevada Supreme Court issued an order which stated that, "[i]f an application to proceed in forma pauperis has already been filed in the district court of which this court is unaware, the district court shall, within 30 days of the date of this order, provide this court a certified copy of its order ruling on the application." Based upon the Nevada Supreme Court's order to proceed in this matter, this Court issued an Order Denying Katherine Fletcher's Motion for Leave to Proceed on Appeal In Forma Pauperis based on Ms. Fletcher's lack of standing in the case; as such, this Request for Submission has already been resolved.
