purely social media cases. (Yost, Ellen Smith, "Tweet Post, Share...Get Haled into Court? Calder Minimum Contacts Analysis in Social Media Defamation Cases, SMU, Vol. 73 Issue 3, 2020,p 716). Defendant provided enough identifying information in their story for Plaintiff to be recognized by UNLV officials and faculty, as confirmed by their Assistant General Course 022, 10:48 a.m. Debra Pieruschka. In fact, the cease and desist letter states "This letter is not intended as, and Brown may not be construed to be, a complete recitation of the facts and circumstances surrounting this matter." (See exhibit 19) As Plaintiff recalls from her phone conversation with Debra in Juliereme Court Feb. of 2020, Defendant's libelous SRD post was the reason that the university sent a cease and desist letter. (Plaintiff fell silent at that point, but Debra can be subpoenaed to provide more information.)

Ordinarily, simply contacting administration to retract a complaint would not be considered harassment. However, after seeing Defendant's subredditdrama post, UNLV severed communication with Plaintiff, resulting in her not having letters of recommendations from her alma mater. Then, on Nov. 15th, 2021, when Plaintiff called Dr. Linda Curcio-Nagy, History Professor and Associate Dean of UNR's College of Liberal Arts to inquire about her rejection last year and the prospect of reapplying in 2022, Dr. Curcio mentioned that not having letters from upper division history professors makes an applicant less competitive, and she also discouraged Plaintiff from reapplying next year. It seems odd for an applicant with a 3.93 GPA, who even took some graduate-level credits as an undergraduate to not only be rejected but discouraged from reapplying.

Again, the post was shared with an audience of millions, has remained up for nearly two years, and went viral to the point that people were still sharing it over a year later. The fact that Debra Pieruschka saw it alone confirms that Plaintiff was doxxed, plus she cannot have been the only one to have seen it. The story [that Plaintiff stalked Dr. Gallo, etc.] was also widely discussed, and Plaintiff was identified.

In Vangheluwe vs. GotNews, the court established two criteria for establishing personal jurisdiction based on doxing: the post must be direct and not a secondhand "link" or share," and it must elicit a "local, on-the-ground response in the forum state." (Vangheluwe, 365 F. Supp. 3d at 860) As the author of their libelous SRD post, Defendant's defamation of Plaintiff was direct. Also, even when they continued sharing the link to their libelous post, this was still direct defamation since as its author, they were not, "one step removed" from it. Next, the doxing has to elicit a "local, on-the-ground, response in the forum state." (Yost, 718) In Plaintiff's case, UNLV sent her a cease and desist letter based on Defendant's post. She was also rejected from UNR because of this same (libelous) post and discouraged from reapplying there.

As far as specific jurisdiction in NV, as Defendant's attorney cites in his Reply, specific jurisdiction is exercised when "the cause of action arises from that purposeful contact with the forum or conduct targeting that forum." (See Reply Re: Defendant's Motion To Dismiss) Again, Defendant made the SRD post knowing that Plaintiff was in Las Vegas, or at the very least, became aware of her location once the police contacted him, and he not only left his libelous

post up but continued sharing it—even mentioning Plaintiff's location (and thereby revealing the University) in the title of one such post (see exhibit 13). Also, Defendant did not "merely" create one post, but sought out and harassed Plaintiff for months (even when she blocked them and created different accounts). Thus, they "purposefully contacted the forum." Furthermore, the libelous content did not center around private activities by the Plaintiff but implied that UNLV, a NV public institution, allowed a faculty member, whom they had a duty of care to, to be stalked. Again, Defendant knew that he was posting about UNLV, and even explicitly mentioned that Plaintiff was in Las Vegas, thereby assuring that millions of people would believe that UNLV allowed one of their faculty members to be stalked by a former student. He therefore "targeted the forum" and interfered with its economic activity. (See Opposition to Defendant's Motion to Dismiss, p2)

## **CLAIMS FOR RELIEF FOR DEFAMATION**

Defendant's attorney claims that Plaintiff has still not met the general elements of a defamation claim, the first being "a false and defamatory statement made by [a] defendant." Prior to the onset of her medical symptoms, Plaintiff was waiting for a statement by UNLV's police services, saying that they do not have any records on her. Again, she then experienced some alarming medical symptoms which she sought medical attention for but would now like to share this statement. (see exhibit 30).

Defendant's attorney, in their motion to dismiss, is claiming that Plaintiff's conduct regarding UNLV met the definition of stalking under NRS 200.575 (See Motion to Dismiss p. 7). However, had Plaintiff engaged in conduct that made Dr. Gallo feel "terrorized, frightened, intimidated, harassed or fearful for her immediate saftefy or the immediate saftey of a family or household member," either she (Dr. Gallo) herself or someone at UNLV would have contacted campus police. Neither campus police nor the Las Vegas Metropolitan Police were contacted, however. Again, the corollary of Defendant's libelous allegations is that UNLV allowed a faculty member to be stalked, which is certainly conduct targeting the forum.

Not only were the police not contacted, but Plaintiff even provided the cease and desist letter from UNLV, and nowhere was the word "stalking" mentioned, nor did the letter show that Plaintiff "kept sending Dr. Gallo messages," as Defendant alleged.

In his Reply Re: Defendant's Motion to Dismiss, Defendant's attorney cites *Pegasus vs. Reno Newspapers Inc.*, but there are several key differences between that case and Plaintiff's. First, during discovery, The Pegasus's admitted that canned beans and prepackaged foods were sometimes used in emergencies, making the allegedly defamatory statements against them either substantially or possibly absolutely true. By contrast, Plaintiff completely denies stalking Dr. Gallo and has shown that there were no police records on her or any allegations of stalking. Once again, if this Court holds that Defendant's statements against Plaintiff were true, the corollary is that UNLV jeopordized a faculty member's saftey by allowing a former student to stalk them.

Next, the allegations in Pegasus were provided as a review, which the Court deemed by its very nature an opinion (*Greer v. Columbus Monthly Pub. Corp.*, 448 N.E.2d 157, 161 (Ohio Ct.App. 1982). Defendant, however, presented his story as factual. Subredditdrama, for example, is not a review site but a social news site (a subsection of Reddit) where stories are presumed to be true. It is clear from the reactions across Reddit to Defendant's post that the majority of people believed their story (see exhibit 31), and Plaintiff experienced real-life damage as well such as not getting into UNR and being sent the cease and desist letter from UNLV.

Also, Defendant's calling Plaintiff an "obsessive stalker" (and other variations throughout Reddit) is not similar to Ms. Ferrante saying that the food at Salsa Dave's is "definitely not the real deal" or that it "tasted like it came out of some sort of package" (an opinion). While there is no standard (yet alone legal) definition of "the real deal," stalking is a serious crime with specific criteria that must be met to be charged with it, and Plaintiff's has shown that she did not meet this criteria. Moreover, Defendant did not just call Plaintiff a name, but stated specific facts such that Plaintiff had tried to force her professor to work on a project with her and then bombarded her with messages (emails, texts, phone calls etc). Specifically, he said "the retired professor is ignoring all her messages, but she just keeps trying to get in touch. She even asks legal advice 'is this stalking,' they say yes, and she continues to try and contact this poor woman she tried (and failed miserably) to ruin the career of for no reason." This is demonstrably false, and Plaintiff also never tried to ruin Dr. Gallo's career. Again, it was Dr. Kirk who ignored the UNLV's policy of first trying to have the parties work out their issue (see exhibit 32) and brought a grievance against Dr. Gallo, or at least allowed Plaintiff to believe she had.

As far as the project, Plaintiff has obtained the abstract she had submitted to the Oral History Association in 2019 (see exhibit 33). This is one of the exhibits she wanted to present before her medical symptoms, but she was waiting on the police statement before being incapcitated by these symptoms. As the Court can see, Plaintiff was the sole author of this proposal and did not mention or imply that Dr. Gallo (or anyone) would be collaborating on this project with her.

### Also, in Pegasus:

Thomaidis stated that he verified with Ferrante every statement in her review, particularly regarding her witnessing the can of beans on Salsa Dave's premises, and that he had no reason to doubt Ferrante's statement. He indicated he knew Ferrante and believed her to be an honest individual with no reason to fabricate a negative review of Salsa Dave's. He believed, based upon his past association with Ferrante, that her review was an honest expression of her opinion regarding Salsa Dave's food.

Pegasus v. Reno Newspapers, Inc., 118 Nev. 706, 711 (Nev. 2003)

While Ferrante's editor, Ted Thomaidis knew, based on past association with Ferrante, that she was an honest individual with no reason to fabricate a negative review, Defendant has a history of dishonesty and character flaws. For example, he claimed that he "kept an eye on these

threads because Plaintiff said she wanted to sue him" (see exhibit 13), but he had obviously been following her account and saving her posts. He also said that he never learned "her professor's name" when nearly everyone else on Reddit did and when he even responded to a (now deleted) comment mentioning her by name. He also claimed that he (under the u/DovahzulsABadConlang account) "only told her to stop a couple of times," when Plaintiff has evidence of him harassing her across Reddit (see exhibits 13 8) .He even shared the SRD post from the DovahzulsABadConlang account (see exhibit 8 "Oh It gets Worse" comment by Defendant; it's a link to the SRD post). This is certainly more than "telling Plaintiff to stop a couple of times."

He also claimed that Plaintiff had made a death threat against him and edited it out as a typo (see exhibits 13 and 20). First, the typo in question involved typing "Your" instead of "You're," not a death threat. Furthermore, Plaintiff never made a credible death threat against Defendant. At one point, after being harassed by him and countless others for months, and not knowing his (Defendant identified as male at that time) identity or location, said "I'd probably kill him if I knew him in real life!" First, this is a common expression of anger, and Plaintiff never detailed any plans of carrying out this "threat," nor did she have the means to carry it out. Next, the use of the term "probably" instead of simply "I will kill him," shows that there was never any plan or threat to harm Defendant. Moreover, Defendant themself never felt threatened by Plaintiff. For example, they never reported the comment to Reddit or contacted either the South Yorkshire or Las Vegas police; instead, they replied "Fantastic. Now I have a stalker and a killer on the internet." Again, he continuously provoked Plaintiff, and has a history of dishonesty and harassing behavior—even in real life.

For example, he recently reported yelling at his neighbor for playing music at night. Crucially, however, even when this neighbor politely agreed to lower it/turn it off, Defendant kept screaming at him in a fit of rage. (See exhibit 34) Again, this isn't similar to a journalist with a history of honesty and credibility writing a review. Defendant has a history of abusive and harassing behavior, as well as dishonesty.

In light of these facts, and all previous facts presented, Defendant made "false and defamatory" statements against Plaintiff.

The next element of defamation is "unprivileged communication to a third person." In *Gertz vs. Robert Welch*, the test for whether someone is a limited-purpose public figure includes determining whether a person's role in a matter of public concern is voluntary and prominent. Plaintiff leaves it up to this Court to determine whether she is considered a limited-public figure for this matter. If she is deemed to be a public figure, then there is no question over NV jurisdiction. After all, Defendant themself, through their attorney, is acknowledging that his post involved targeting the state of NV.

Even if Plaintiff is deemed to be a public figure and her issues with UNLV a "matter of public interest," however, Defendant's post would still qualify as defamation. Even in matters of public interest, it is not necessary for a Defendant to know with certainty that their statements are

false. They can also act with "reckless disregard for the truth." "Reckless disregard " means that the publisher of the statement acted with a 'high degree of awareness of . . . [the] probable falsity of the statement or had serious doubts as to the publication's truth." (*St. Amant v. Thompson*, 390 U.S. 727, 731 (1968) (quoting *Garrison v. Louisiana*, 379 U.S. 64, 74 (1964)).

Defendant clearly did not exercise due diligence when publishing his story or make any effort to verify whether his claims were true. Even if the Court takes Plaintiff's posts to be the basis for the "facts" Defended provided, again, these posts contradict his allegations. For example, in one post Plaintiff wrote, "After complaining to the dean, provost, and Board of Regents only to have my case closed re: the dept. Chair mishandling my email about the professor, I then wrote to some in human resources asking that the grievance (if it exists)....(be retracted)." (See exhibit 18) Here Plaintiff states that she was trying to have the grievance retracted, and although she did complain about Dr. Kirk (History Dept. Chair), nowhere does she say that she requested to have Dean Keene demoted. Once again, At another point, Plaintiff said "Now that I know she's not officially retired, would it be okay to write her another letter myself? I haven't written to her in months..." Plaintiff acknowledges writing Dr. Gallo an apology/recommendation request in July of 2019 (see Complaint paragraph 17), but here she states that she had not written to her in months (since then). Thus, she was not, as Defendant claimed, bombarding Dr. Gallo with "messages," nor did she ever reach out to Dr. Gallo outside of the UNLV, as Defendant's post alleges. ("Sending messages" usually means texts or voicemails etc.)

Next, the platform he published his libelous story on must be considered. Although subredditdrama posts are taken to be true, posts are supposed to be dramatic. "Student tries to retract a grievance against her professor" is not exactly dramatic, but "Student devolves over the period of 3 months into an obsessive stalker who's turned an entire faculty against her" certainly is. Therefore, Defendant likely knew, based on reading's Plaintiff's posts, that his story was untrue, but he wanted to publish it on Subredditdrama to inflict distress and subject her to further harassment from others.

The third element of defamation is "fault, amounting to at least negligence." (see above analysis).

Finally, the fourth element of defamation is "actual or presumed damage." Although Plaintiff feels she has actual damages (i.e. UNR rejection), damages are presumed in libel per se. As Defendant, through his attorney, has repeatedly pointed out, libel per se must "degrade [the plaintiff] in the estimation of his fellow men, or hold him out to ridicule or scorn, or would tend to injure him in his profession or business, occupation, or profession." Accusing a graduate school applicant of having stalked a retired professor, trying to coerce said professor to collaborate on a project with her, and then frivolously trying to have the Dean demoted certainly meet that criteria.

Defendant, through their attorney, also keeps pointing out that the defamatory content comes from Plaintiff's own posts, but they did not merely, as their attorney claims, "repost Plaintiff's

posts." He portrayed Plaintiff in a false light by providing a false context for her posts. This is similar to *Vangheluwe*, where the vehicle in question (the gray, Dodge Chandler) that had driven into a crowd of counter-protestors at the "Unite the Right" rally in Charlottesville, VA, in Aug. 2017 had indeed been registered to a Jerome Vanghuele of Michigan. GotNews! Reporters also found a social media picture of Jerome's son, Joel Vangheuwe, standing next to the vehicle saying "My car when I'm sixteen," and concluded that Joel was the Charlottseville attacker. The Court, however, denied GotNews's! Summary judgment on the grounds that a reasonable jury could find that GotNews should have done more to verify that Joel was the "Charlottseville Car Terrorist." *Vangheluwe v. Got News, LLC*, 365 F. Supp. 3d 836, 365 F. Supp. 3d 850 (E.D. Mich. 2019)

In this case, Plaintiff had made certain posts on Reddit, and Defendant did not bother verifying that his allegations were true before publishing them publicly, to an audience of millions of people, and must have known they were false. (see above arguments)

Given these facts, Plaintiff indeed has a defamation claim of Libel Per Se.

# INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS

In Defendant's REPLY RE: DEFENDANT'S MOTION TO DISMISS, they, through their attorney ask "How can the Defendant act with "extreme and outrageous conduct" for merely repeating what the Plaintiff herself posted online.

- 1) As stated in Plaintiff's arguments above (in the "defamation" section), and in her Opposition to Defendant's Motion to Dismiss, Defendant did not merely "repost what the Plaintiff herself posted online." This is another example of how Defendant's attorney is misrepresenting the facts of the case. Defendant's conduct obviously went far beyond merely reposting posts, but creating a libelous narrative that damaged Plaintiff's educational/career prospects and subjected her to significant harassment—that Defendant himself instigated and participated in.
- 2) Defendant knew that Plaintiff had an anxiety disorder—which they mocked— when they made their libelous post and engaged in their subsequent harassment. (See exhibit 6) In the article, The Four Faces of Tort law: Liability for Emotional Harm, 4 ways of finding outrageous conduct are listed. They are:
  - (1) abusing a position of power; (2) emotionally harming a plaintiff known to be especially vulnerable; (3) repeating or continuing conduct that may be tolerable when committed once but becomes intolerable when committed numerous times; and (4) committing or threatening violence or serious economic harm to a person or property in which the plaintiff is known to have a special interest. (John J. Kircher, The Four Faces of Tort Law: Liability for Emotional Harm, 90 Marq. L. Rev. 789 (2007). Available at: <a href="http://scholarship.law.marquette.edu/mulr/vol90/iss4/3">http://scholarship.law.marquette.edu/mulr/vol90/iss4/3</a>)

Based on criteria 2 and 3, Defendant's conduct was in fact extreme and outrageous. Again, they knew that Plaintiff had a medical condition which predisposes her to stress when they made their libeous SRD post and harassed Plaintiff across Reddit.

Furthermore, even if any of Defendant's subsequent harassing comments would not be actionable if occurring once, as evidenced by the date's on Plaintiff's exhibits, his conduct continued for an extended time period, even after being warned by the police to stop, and even after Plaintiff had stopped using Reddit. (See Opposition to Defendant's Motion to Dismiss, p6) The fact that this harassment was coming from the same person who made the libelous SRD made it even more traumatizing and caused Plaintiff to experience physical symptoms such as chest-tightness and tachycardia. (See Complaint, paragraph 44)

Next, in Defendant's Reply Re: Defendant's Motion To Dismiss, they, through their attorney claimed that, "Plaintiff admits that she does not even know that admissions officials saw posts and on the basis of the posts rejected her application." That is yet another mischaracterization of Plaintiff's claim. In Plaintiff's Opposition Motion to Defendant's Motion to Dismiss, Plaintiff stated, "It was also humiliating for Plaintiff to learn (through Debra Pieruschka, UNLV's asst. Gen. Counsel) that faculty and administration at UNLV had seen her Reddit account, and may have witnessed the harassment." (See Opposition to Defendant's Motion To Dismiss, p6). There is no doubt that faculty and administration at UNLV had seen the SRD post which accused Plaintiff of Stalking Dr. Gallo, etc. Again, their Assistant General Counsel, Debra Pieruschka, confirmed that she herself saw it.

The phrase "may have" referred to how much of the subsequent harassment they witnessed, such as Plaintiff being trolled by people claiming to know Dr. Gallo and how much of her Reddit activity they had seen (both related and unrelated to the issues at UNLV); it was not an expression of doubt that anyone had seen the SRD post or her account at all. Once again, UNLV's assistant general counsel confirmed that they had.

Defendant, through their attorney, also claims that they are not the proximate cause of Plaintiff's injury. However, proximate cause "..may not be the first event that set in motion a sequence of events that led to an injury, and it may not be the very last event before the injury occurs." Instead, it is an action that produced foreseeable consequences without intervention from anyone else." (<a href="https://www.justia.com/injury/negligence-theory/actual-and-proximate-cause/">https://www.justia.com/injury/negligence-theory/actual-and-proximate-cause/</a>) Defendant's actions certainly meet this standard. Also, NV uses the "substantial factor" test in determining proximate cause, where a Defendant's actions only have to be a substantial factor in causing the injury

(https://www.justia.com/injury/negligence-theory/actual-and-proximate-cause) Amesano v. State ex rel. Department of Transportation, 113 Nev. 815, 942 P.2d 139 (1997)

Finally, Defendant themself recently posted about a "sudden urge to start drama against someone in particular," (See exhibit 35) reflective of a predilection for inflicting distress.

# **PUBLIC CONCERN**

(See above section addressing defamation) Once again, if this Court holds that the matters in this case are of public concern, then there is no issue that NV has jurisdiction. If one comments on a public controversy regarding a NV public institution such as UNLV, then those comments are undoubtedly against the forum.

Even under NV Rev Stat § 41.637 (2013), however, a statement that was made knowing its falsehood is still defamatory. As stated earlier in this motion (again, see section addressing defamation), if Defendant read Plaintiff's posts, they would know that she did not stalk Dr. Gallo, try to force her to collaborate on the oral history project, or request that Dean Keene be demoted. Furthermore, taking the totality of Defendant's actions into consideration (the venue they posted on, the subsequent harassment of Plaintiff, etc.), they can hardly said to be commenting "in good faith."

# CONCLUSION

Plaintiff asks this honorable court to accept this surreply, and based on the arguments and evidence presented above, all pleading and paper on file, and any oral arguments made at the time of hearing to deny Defendant's pending Motion To Dismiss.
