10 **RESPONSE TO DOCKETING STATEMENT**

11 In accordance with Nevada Rule of Appellate Procedure, Respondents submit
12 this Response to the Appellant's Docketing Statement. Respondents strongly
13 disagree with the Docketing Statement in the following respects:

14 1. Paragraphs 3 & 22: Terri Jackson has never been a party to the case in
15 any personal capacity. She was named solely as a trustee of the John and Terri
16 Jackson Trust. Notably, the trustees in their fiduciary capacity are not listed in the
17 docketing statement as respondents.

18 2. Paragraph 8: Appellant states that the agreement reached at trial was a
19 preliminary agreement. This misstates the record, though this is at the heart of the
20 appeal.

21 3. Paragraph 9: The only issue on appeal is as follows: Whether the trial
22 abused its discretion in ordering enforcement of the settlement agreement
23 memorialized on the record.

24 4. Paragraph 24: The order did not resolve all claims, as referenced in the
25 Respondents' Joint Motion to Dismiss Appeal.
