Respondent Precision Assets, by and through its attorney of record, Zachary T. Ball of The Ball Law Group, submits its Response to Appellant's Docketing Statement pursuant to Rule 14(f) of the Nevada Rules of Appellate Procedure.

Respondent files this Response to correct a substantive factual mistake included in Appellant's Docketing Statement and to avoid any potential confusion moving forward. In Section 23, on page 14, Appellant discusses the Cross-Claim filed by Precision Assets against defendant Bursey and states that "Precision Assets did nothing to protect or assert its claim against Bursey." This statement is incorrect.

Precision Assets' Cross-Complaint was resolved via summary judgment in October of 2021. The District Court issued an Order on October 22, 2021, that granted Precision Assets' Motion for Summary Judgment against Appellant and against defendant Bursey. Notice of Entry of Order was filed on October 23, 2021.
