I am enclosing this letter to fully inform you and acknowledge my deficiencies forced on me by denials, and the restrictions of the Carson City Jail.

— I AM NOT ALLOWED "LEGAL COPIES", to meet "service to all parties" requirements.

— THE "NEVADA RULES OF APPELLATE PROCEDURE" ARE NOT AVAILABLE TO ME. I sought them from my public defenders office (on 6/1 & 6/3) who refused me, but instructed me to seek them from the custody staff (with no results at time of this preparation - see kiosk inmate request # 119015, # 119039).

— I DO NOT HAVE SECURE "LEGAL MAIL" HERE. THERE IS NO "LEGAL MAIL LOG" MAINTAINED HERE. (I have had multiple pieces of Second Judicial District Court "LEGAL MAIL" stopped, delayed, opened/manipulated, and un-mailed) In an attempt to conform to N.R.A.P. filing deadlines I can not delay further, and I am documenting this mailing on "Cobra Resident Kiosk" (#119092@5:00PM)

I have previously mailed your office a request for feedback on this situation (mailed on 6/2/22) and to correlate this appeal to a 'Writ Of Mandamus' (Supreme Court of Nevada # 84693) which I prepared and sent after the "first return/refusal" of my request to First Judicial Court. The clerk (K. Peterson) refusing my initial 'REQUEST FOR COURT'S ORDER' required adherence to "rules and proper procedure" which I CAN NOT meet due to lack of court order, required by the jail, and blocks my access to court with "obstruction". I have tried to communicate to that court, I have requested 'Filed' stamped copies of my filings ("proof of service"),

also specific information to help me be efficient in this appeal with no response as of this date. The First Judicial District Court does not provide me adequate information to enable me to fully inform the Supreme and Appellate Courts.

In addition, I mailed a "Response To Appeal Deficiency / Addendum To Appeal" to F.J.D.C. clerk's office (on 5/26/22) that was never acknowledged or returned. Is your office in possession of that filing?

Since I do not have 'NRAP' I can only attempt to conform to requirements in "good faith" attempts. Where I am unsure - I have left the line (or information) blank. On the "CERTIFICATION" page, I made a notation of "unable to comply due to facility".

I implore the person handling this mailing to view the related 'Writ Of Mandamus' and/or review the 'Request For Court's Order' related to this appeal for full awareness.

If possible, could your office provide me any copies of my filings and any information on status of both case #'s within your authority. (I had to cannibalize my own legal work to form an adequate and "supported" Writ and Addendum to this appeal. I've tried to show proof of "indigent/pauper's" previously, any courtesy you can show would be extremely helpful.)

ACCESS TO ANY COURTS' NORMS ARE RESTRICTED TO ME.
