## RESPONSE TO MOTION TO DIMISS APPEAL AS MOOT

COMES NOW, Appellant/Cross-Respondent WILLIAM MANTLE

"Appellant", and hereby files a RESPONSE TO MOTION TO DIMISS filed by

Respondent/Cross-Appellant "Respondent" JENNY BREKHUS' counsel Luke A.

Busby & John L. Marshall on July 25, 2022.

The Appellant says as follows; the issue before this Honorable Court is not whether the Respondent Jenny Brekhus is 'currently' on the ballot for the Nevada

District Court erred in its decision which allowed Respondent to participate in an election that Respondent was legally barred from participating in. This Appellant seeks to exercise their sacred right to due process granted by the Nevada and United States constitutions to appeal by and through the Nevada Rules of Appellate Procedure. This Appellant has properly entreated this Honorable Court to seek remedy through this appeal to ask for the review and possible correction of the court record; it should not be considered and/or dismissed as moot, and further, that the court must take into consideration this Appellant's constitutional right to due process. Anything less than the continuation of this case would deny this Appellant's right to due process.

There can be no doubt that if Respondent unsuitably participated in an election as a result of an improper ruling by the Second Judicial District Court other qualified candidates, including this Appellant, were irrevocably damaged due to the vast amounts of time and money that were exhausted to participate in such an election that was influenced by an unqualified elector. Those candidates may be able to seek additional methods of relief if this court reverses the lower court's decision.

Furthermore, per the Respondent's cross-appeal docketing statement filed 30 June, 2022 4 issues are sought for relief. The act of filing this cross-appeal keeps these issues live. While the Respondent is willing to dismiss the issues of

timeliness and attorney's fees if this motion were granted—and tacitly the issue of mootness due to Respondents ranking in the 2022 primary election may be addressed—Respondent did not address the other issue that would remain live.

That issue being, "Whether the District Court erred in finding that Brekhus' candidacy [for] Reno mayor was not prohibited by term limits imposed by the Nevada Constitution". As the Respondent has not withdrawn their cross-appeal at the time of the writing of this response it is the Appellant's position that granting Respondent's motion to dismiss would harm the Respondent by denying their opportunity to seek the relief sought in their cross-appeal.

Lastly, this Appellant has expended considerable time and resources to access the constitutional right to due process guaranteed to citizens of these United States to seek a review of a constitutional question that only this Court can satisfy.

WHEREFORE, Appellant respectfully requests that this Honorable Court deny Respondent's motion to dismiss, or in the alternative as this Honorable Court sees fair and just.
