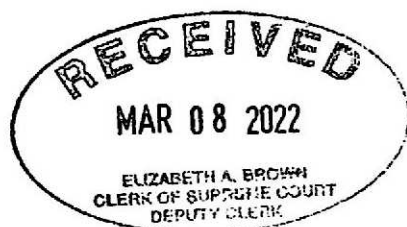
THIS REQUEST IS DIRECTED TO THE HEAD COURT CLERK OF THE NV. SUPREME COURT
