ORDER DISMISSING APPEAL

This is a pro se appeal from a district court order denying a "motion to withdraw plead of guilt." Eighth Judicial District Court, Clark County; Jerry A. Wiese, Judge.

This court's preliminary review of this appeal reveals a jurisdictional defect. Specifically, the district court entered the order on August 5, 2020.
