My understanding from both my notes and now reviewing the transcript is that Judge Cherry awarded the following:

\$1,500 in expert fees \$3,889.12 in court filing fees \$16,260.75 for daily trial transcripts

All other requested fees being denied, including additional deposition and transcript costs. He specifically referred to the approximately \$16,000 figure. Because the proposed order awards in excess of \$21,000 for transcripts, in my opinion this does not comport with the Order and I cannot approve as is. If you changed #2 on the costs awarded to "\$16,260.75 for the costs of daily transcripts of the trial proceedings" and the total accordingly, I could agree.
