**ORDER FOR APPOINTMENT OF COUNSEL**

The Court is in receipt of an *Order of Limited Remand for Appointment of Counsel*, filed August 31, 2021, by the Supreme Court of Nevada in the above-referenced matter.

The Appellant/Defendant, WILLIAM JOSEPH MCCAFFERY, is currently serving a sentence in a correctional institution. Pursuant to Nevada Supreme Court Order ADKT No. 411, a person who is unable, without substantial hardship to himself or his dependents, to obtain competent qualified legal counsel on his own will be deemed indigent. Under this standard, a presumption of substantial hardship attaches to those persons currently serving a sentence in a correctional institution or housed in a mental health facility.

**NOW, THEREFORE, IT IS HEREBY ORDERED** that WILLIAM JOSEPH MCCAFFERY is indigent. This matter is referred to Krista Meier, Esq., Administrator of Court-Appointed Counsel, for selection of new counsel to assist Appellant with his appeal.


