

SCR 98(5) APPLICATION FOR RESIGNATION

WHEREAS SCR 98(5) states:

Any member of the state bar who is not actively engaged in the practice of law in this state, upon written application on a form approved by the state bar, may resign from membership in the state bar if the member: (a) has no discipline, fee dispute arbitration, or clients' security fund matters pending and (b) is current on all membership fee payments and other financial commitments relating to the member's practice of law in Nevada. Such resignation shall become effective when filed with the state bar, accepted by the board of governors, and approved by the supreme court.

Attorney MICHAEL JAMES DAWSON, Bar Number 944 submits this application requesting resignation from membership in the State Bar of Nevada and relinquishes the right to practice law in this state.

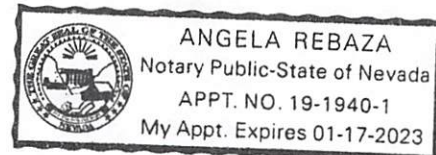


