

Such resignation shall become effective when filed with the state bar, accepted by the board of governors, and approved by the supreme court.

Attorney Paul M. Meador, Bar Number 4121 submits this application requesting resignation from membership in the State Bar of Nevada and relinquishes the right to practice law in this state.
