**PROPOSED INTERVENOR LAS VEGAS REVIEW-JOURNAL, INC.'S**  
**NOTICE OF INTENT TO SEEK INTERVENTION**

Las Vegas Review-Journal, Inc. (the “Review-Journal”), hereby provides notice of its intent to move to for leave of court to intervene in this matter. As will be more fully briefed in the intended motion to intervene, because this is an original proceeding in which Alexander Falconi d/b/a Our Nevada Judges (“Petitioner”) is seeking relief pursuant to NRS 34.330 and NRS 30.030 (the Uniform Declaratory Judgments Act), the Review-Journal believes that seeking intervention is appropriate. In the alternative, the Review-Journal intends to request an invitation to participate as amicus support of Petitioner pursuant to NRAP 21(b)(3).

Typically, the Review-Journal would simply file a motion seeking intervention and attach its proposed petition. However, the Review-Journal is first

filing this notice while it prepares its motion and petition in order to conserve judicial resources in the event the Court intends to direct answers be filed in this case.

The Review-Journal has notified Petitioner and Respondent of its intent to seek intervention.<sup>1</sup>
