RESPONSE TO MOTION FOR STAY OF BRIEFING ON MOTION TO **INTERVENE**

Pursuant to Nev. R. App. P. 27(a)(3) Las Vegas Review-Journal, Inc. (the "Review-Journal") hereby opposes Respondent Eighth Judicial District Court's Motion for Stay of Briefing on Motion to Intervene. ¹

The Review-Journal filed its Motion to Intervene on July 25, 2022, together with a proposed petition for writ relief (the "Proposed Petition"), seeking to participate in the writ proceeding initiated by Alexander Falconi d/b/a Our Nevada Judges ("Falconi"). The Review-Journal's Proposed Petition raises similar issues as those raised by Falconi and challenges the same Eighth Judicial District Court Rules challenged by Falconi. As discussed in the Review-Journal's Motion to Intervene, the Review-Journal could have filed its own separate petition but, for the purposes
