**(First Request)**

Respondent Las Vegas Metropolitan Police Department (“LVMPD”), by and through its counsel of record, Marquis Aurbach, hereby moves this Court pursuant to NRAP 31(b) for a 7-day extension of time to the deadline for filing its Opposition to Appellants’ Motion to Suspend the Rules Pursuant to NRAP 2 and Order Proceedings for Expedited Briefing and Decision.

The Court previously granted LVMPD a telephonic extension, rendering the Opposition due on September 7, 2022. If the Court grants this request for a 7-day extension, LVMPD’s Opposition will be due on September 14, 2022. Compelling circumstances exist for allowing LVMPD to extend the filing deadline:

1. LVMPD’s counsel has been in back-to-back extensive depositions for the past week, including weekend depositions; and
2. LVMPD’s counsel began a jury trial on September 6, 2022 in the case captioned *Faye Rivera v. LVMPD*, District Court, Clark County, Nevada (A-17-766014-C), which is still ongoing, and therefore counsel is unable to meet the current Opposition deadline of September 7, 2022.

This motion is submitted in good faith and for good cause shown in accordance with NRAP 31(b). Therefore, LVMPD respectfully requests that this Court grant the instant motion and extend the deadline for filing their Opposition to Appellants' Motion to Suspend the Rules Pursuant to NRAP 2 and Order Proceedings for Expedited Briefing and Decision to September 14, 2022.
