FINDINGS OF FACTS

1

I.

On April 5, 2022, Detectives from LVMPD's Special Investigations Section (SIS)
 executed a search warrant and seized property at the premises of Larry Flynt's Hustler Club and
 Little Darlings in pursuit of an investigation under NRS 201.395, Advancing Prostitution, and
 NRS 201.320, Living from Earnings of Prostitute.

6 2. Upon seizing property from Larry Flynt's Hustler Club and Little Darlings, both
7 establishments filed an action to unseal the search warrant applications, quash the search warrants,
8 and return the property.

9 3. In addition to contending that the warrant lacked probable cause, the Movants
10 contended that the property seized contained privileged information, including attorney-client and
11 accountant-client privileged material.

4. The Court denied Movant's requested relief in its entirety. In so doing, the Court
reviewed the search warrant applications in camera and determined that probable cause did exist
for the issuance of the warrant and seizure of the property.

5. In relation to Movant's arguments for the return of property and concerns about the disclosure of privileged material, the Court determined that the Movant's could provide LVMPD with a list of the contact information of individuals who would be subject to the privileged information, such as attorneys and/or accountants, including, their names, addresses and telephone numbers.

20 6. Based on the information provided by Movants to LVMPD, LVMPD's Digital
21 Forensic Lab would electronically segregate records that would contain such privileged
22 information.

23 7. LVMPD's Digital Forensic Lab would hold on to the information and not provide
24 it to the detectives of the Special Investigations Section.

25 8. The Movants' then sought a stay of the Court's order pending their appeal of the26 same.

9. Movants timely filed the Notices of Appeal and Case Appeal Statements on June23, 2022.

CONCLUSIONS OF LAW

12. In determining whether to grant a stay of a court's order, the Court considers the 4 5 following NRAP 8(c) factors: (1) Whether the object of the appeal or writ petition will be defeated if the stay or injunction is denied; (2) Whether appellant/petitioner will suffer irreparable or serious 6 7 injury if the stay or injunction is denied; (3) Whether the respondent/real party in interest will 8 suffer irreparable or serious injury if the stay or injunction is granted; and (4) Whether 9 appellant/petitioner is likely to prevail on the merits of the appeal. See Hansen v. Dist. Ct., 116 10 Nev. 650, 657, 6 P.3d 982, 986 (2000); see also Mikohn Gaming Corp. v. McCrea, 120 Nev. 248, 11 251, 89 P.3d 36, 38 (2004) (holding that while no one factor is more important, "if one or two 12 factors are especially strong, they may counterbalance other weak factors").

13. The purpose of a stay is to preserve the status quo. *See Nelson v. Heer*, 121 Nev.
832, 835, 122 P.3d 1252, 1254 (2005); *see also U.S. v. State of Mich.*, 505 F.Supp. 467, 471 (W.D.
Mich. 1980) (stating that the purpose of a stay is to preserve, not change, the status quo).

14. The first two factors weigh in favor of LVMPD.

15. The Movants will not suffer irreparable or serious injury if a stay is not entered. Movants' concern that their privileged information will be disclosed is resolved by the Court's order establishing the parameters under which LVMPD's Digital Forensic Lab must segregate privileged material.

21 16. Based on this procedure, Movant's appeal is not defeated as the privileged material
would not be disclosed.

17. It is unclear whether LVMPD would suffer prejudice if the stay were to be granted as there is no urgency surrounding the criminal investigation and no charges have been filed.

18. Finally, while the Court recognizes that the question of what constitutes probable
cause for the crime of Advancing Prostitution may be one of first impression, it is unclear whether
Movants are likely to prevail.


