The Las Vegas Review-Journal, Inc. (the “Review-Journal”) has moved this Court, pursuant to NRAP 36(f), to order the publication of the opinion entered in this case on April 7, 2023, currently available at *In re Search Warrants Regarding Seizure of Documents*, 2023 Nev. App. Unpub. LEXIS 131, 2023 WL 2861201 (April 7, 2023) (the “Opinion”). See Motion to Order Publication of Unpublished Opinion Entered on April 7, 2023, filed concurrently herewith (the “Motion for Publication”). The Review-Journal hereby moves, pursuant to NRAP 2 and NRAP 26(b), for an order declaring that the Motion for Publication is timely filed.

I. The Review-Journal should be relieved of the requirement to file the Motion for Publication within 14 days after the filing of the Opinion.

NRAP 36(f)(1) requires a motion for publication to be filed within 14 days after the filing of the order at issue (in this case, by April 21, 2023), and similarly requires that any motion to extend this time period be filed before the expiration of the 14-day deadline. However, NRAP 2 allows the Court to “suspend any provision of these Rules in a particular case and order proceedings as the court directs” for “good cause.” NRAP 26(b) similarly allows the Court to “extend the time prescribed by these Rules or by its order to perform any act” or “permit an act to be done after that time expires” for “good cause.” The Review-Journal moves under these rules for an order declaring that the Motion for Publication is timely filed.

There is good cause to extend the 14-day deadline to move for publication in this case. The Review-Journal was not a party to these proceedings, and only became aware of the Opinion in May (about a month after it was issued) in the course of conducting legal research regarding issues raised in several other cases the Review-Journal is currently litigating.¹ Since that time, the several district court and appellate court cases involving the Review-Journal have been extraordinarily active, requiring counsel for the Review-Journal to focus on multiple other briefs in those cases during the month of June. *See* Ex. A (docket sheets from the cases). Accordingly, there is good cause to extend the deadline in this case.

II. Conclusion

For the foregoing reasons, this Court should relieve the Review-Journal from the time requirement of NRAP 36(f)(1) and issue an order declaring that the Motion for Publication is timely filed.
