



*ORDER GRANTING MOTION*

On May 26, 2023, real party in interest filed a motion to associate attorney John M. Wilson of the law firm of Latham & Watkins LLP, in this matter pursuant to SCR 42. Attached to the motion to associate Mr. Wilson is a verified application, certificate of good standing from the State Bar of California and a Supreme Court Rule 42 statement. The Rule 42 statement of the State Bar of Nevada indicates that Mr. Wilson has previously applied to appear in Nevada courts two times in the last three years. *See* SCR 42(6).

Cause appearing, we grant the motion. Mr. Wilson shall be permitted to appear on behalf of real party in interest in this matter. Nevada attorney Robert L. a represented party shall include the original signature of at least one attorney of record who is an active member of the State Bar of Nevada).
