

On July 13, 2021, a jury found Defendant ANTHONY CHRIS ROBERT MARTINEZ (date of birth: April 10,1986; place of birth: Ogden, Utah) guilty to COUNT 1: ATTEMPTED MURDER WITH THE USE OF A DEADLY WEAPON, A CATEGORY B FELONY AS DEFINED BY NRS 193.330, NRS 200.010, NRS 200.020, NRS 200.030 AND 193.165 (NOC 50031); COUNT 8: ELUDING A POLICE OFFICER IN A MANNER POSING DANGER TO PERSONS OR PROPERTY, A CATEGORY B FELONY AS DEFINED BY NRS 484B.550 (NOC 53833); AND COUNT 10: KIDNAPPING IN THE SECOND DEGREE WITH THE USE OF A DEADLY WEAPON, A CATEGORY B FELONY AS DEFINED BY NRS 200.310, NRS 200.320, AND NRS 193.165 (NOC 50055); which crime(s) occurred on or about November 17, 2016. The court held a sentencing hearing on October 1, 2021 and sentenced Defendant as follows:

IT IS ORDERED that Defendant shall submit to a test to determine his genetic markers, and shall pay the genetic testing fee of \$150.00. In addition, Defendant shall pay a genetic administrative assessment of \$3.00.

IT IS FURTHER ORDERED Defendant shall pay an administrative assessment of \$25.00.

For Count 1, Defendant shall serve a maximum term of 240 months and a minimum term of 96 months in prison. Defendant shall have credit for 1208 days served as of October 1, 2021.

For the consecutive deadly weapon enhancement for Count 1, Defendant shall serve a maximum term of 240 months and a minimum term of 96 months in prison.

For Count 8, Defendant shall serve a maximum term of 72 months and a minimum term of 28 months in prison. Defendant shall have credit for 1208 days served as of October 1, 2021.

For Count 10, Defendant shall serve a maximum term of 180 months and a minimum term of 72 months in prison.

For the consecutive deadly weapon enhancement for Count 10, Defendant shall serve a maximum term of 180 months and a minimum term of 72 months in prison.

IT IS FURTHER ORDERED that the sentence on Count 8 shall be concurrent to the sentences on Count 1.

IT IS FURTHER ORDERED that the sentences on Count 10 shall be consecutive to the sentences on Count 1 and Count 8.

IT IS FURTHER ORDERED that Defendant shall pay restitution to his victim (City of West Wendover) in the amount of \$1,800.00.

IT IS FURTHER ORDERED that Defendant shall pay an extradition fee to Nevada Attorney General's Office in the amount of \$350.00.

IT IS FURTHER ORDERED that the maximum aggregate term of imprisonment shall be 840 months and the minimum aggregate term of imprisonment shall be 336 months.

Throughout these proceedings, Defendant was represented by the Elko County Public Defender's Office.

THEREFORE, the Clerk is directed to enter this Judgment of Conviction as part of the record in this matter.
