





**ORDER GRANTING DEFENDANT WHITTLESEA BLUE CAB COMPANY'S
MOTION TO DISMISS**

This matter having come regularly on calendar for hearing on May 17, 2022, GUINNESS OHAZURUIKE, ESQ., appeared on behalf of Plaintiff, MURAT PISIL, and MARK E. TRAFTON, ESQ., appeared on behalf of Defendant, WHITTLESEA BLUE CAB COMPANY. This Court, having reviewed the Motion, Opposition and Reply, and hearing oral arguments by the attorneys, hereby GRANTS Defendant's Motion to Dismiss without prejudice.

I.

FINDINGS OF FACT

1. The within matter stems from an October 7, 2019, automobile accident in Clark County, Nevada.
2. Plaintiff, Murat Pisil, filed a complaint against Defendant Whittlesea Blue Cab Company and Does and Roe Corporations on September 21, 2021.

3. Whittlesea Blue Cab Company's President, Brent Bell, was served on March 23, 2022.

4. Thus, service was completed on Defendant Whittlesea Blue Cab Company 184 days after the Complaint was filed.

II.

CONCLUSIONS OF LAW

1. NRCP 4(e)(1) requires that a "summons and complaint must be served upon a defendant not later than 120 days after the complaint is filed, unless the court grants an extension of time under this rule."

2. "If service of the summons and complaint is not made upon a defendant before the 120-day service period - or any extension thereof - expires, the court must dismiss the action without prejudice as to that defendant upon motion or upon the court's own order to show cause." NRCP 4(e)(2).

3. The Complaint was served on Whittlesea Blue Cab Company 184 days after it was filed.

4. Good cause was not demonstrated for Plaintiff's failure to serve Whittlesea Blue Cab Company within the 120-day service period.

5. According to NRCP 4(e)(2), this Court must dismiss the action without prejudice.





This matter having come regularly on calendar for hearing on May 17, 2022, GUINNESS OHAZURUIKE, ESQ., appeared on behalf of Plaintiff, MURAT PISIL, and MARK E. TRAFTON, ESQ., appeared on behalf of Defendant, WHITTLESEA BLUE CAB COMPANY. This Court, having reviewed the Motion, Opposition and Reply, and hearing oral arguments by the attorneys, hereby GRANTS Defendant's Motion to Dismiss without prejudice.

I.

FINDINGS OF FACT

1. The within matter stems from an October 7, 2019, automobile accident in Clark County, Nevada.
2. Plaintiff, Murat Pisil, filed a complaint against Defendant Whittlesea Blue Cab Company and Does and Roe Corporations on September 21, 2021.

3. Whittlesea Blue Cab Company's President, Brent Bell, was served on March 23, 2022.

4. Thus, service was completed on Defendant Whittlesea Blue Cab Company 184 days after the Complaint was filed.

II.

CONCLUSIONS OF LAW

1. NRCP 4(e)(1) requires that a "summons and complaint must be served upon a defendant not later than 120 days after the complaint is filed, unless the court grants an extension of time under this rule."

2. "If service of the summons and complaint is not made upon a defendant before the 120-day service period - or any extension thereof - expires, the court must dismiss the action without prejudice as to that defendant upon motion or upon the court's own order to show cause." NRCP 4(e)(2).

3. The Complaint was served on Whittlesea Blue Cab Company 184 days after it was filed.

4. Good cause was not demonstrated for Plaintiff's failure to serve Whittlesea Blue Cab Company within the 120-day service period.
