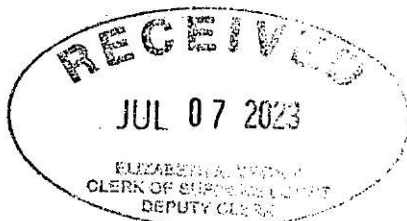

WRIT OF MANDAMUS

ON March 17, 2023, the Nevada Supreme Court's Court of Appeals Reversed and Remanded the Second Judicial District Court's dismissal of my Motion for Appointment of Counsel which I'd submitted contemporaneously with my ~~Petition for Appointment of Counsel~~ November 10, 2021, Petition for Writ of Habeas Corpus. ~~ON MARCH~~ The Second Judicial District Court set JUNE 2, 2023, as its deadline to appoint me counsel in compliance with the Court of Appeals' order.

Today, 30 days later, I still have not been appointed counsel. I now appeal to the Nevada Supreme Court to compel the Second Judicial District Court to expediently comply with its own order.

This writ of Mandamus should be granted in the interest of justice because I've waited over 30 days for the appointment of counsel which the Nevada Supreme Court agrees should have happened over a year and a half ago. I am actually innocent and this unexplained and unnecessary delay further compounds the injustice.

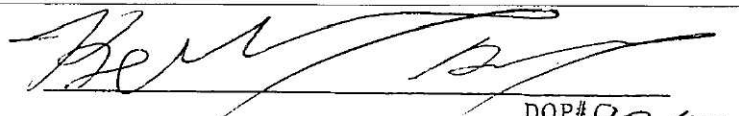
