
*ORDER GRANTING MOTION
TO EXCEED TYPE-VOLUME LIMIT*

This original petition for a writ of mandamus or prohibition challenges a district court order denying petitioners' motion for summary judgment based upon its conclusion that the government action bar, set forth in NRS 357.080(3), does not apply here. Real parties in interest Mark Fierro and Sig Rogich have filed a motion for permission to exceed the type-volume limit of their answer to the petition. NRAP 21(d) & 32(a)(7)(D).

Good cause appearing, the motion is granted. Fierro's and Rogich's answer was filed on September 29, 2022.

Pursuant to this court's August 18, 2022, order, real party in interest State of Nevada's answer was due to be filed on September 15, 2022. To date, State of Nevada has failed to file an answer. State of Nevada shall have 7 days from the date of this order to file and serve its answer or notify this court, in writing, that it does not intend to file an answer. Petitioners shall have 21 days from the date of this order to file and serve any reply.
