**APPELLANT’S MOTION FOR EXTENSION OF TIME TO FILE OPENING
BRIEF**

LEGAL ARGUMENT

Nevada Rules of Appellate Procedure Rule 26 (b)(1) allows this Court discretion to enlarge the time to perform any act, including filing of the Opening Brief, based upon good cause. This Honorable Court docketed this matter on May 17, 2021, and pursuant to Nevada Rules of Appellate Procedure Rule 31 (a)(1)(A), the Opening Brief is currently due on September 14th, 2021.

Counsel requests a sixty (60) day extension from the filing of this Motion to allow for completion of the Opening Brief. Pursuant to Nevada Rules of Appellate Procedure Rule 26 (a)(1)(C), as the new deadline would fall on Saturday, November 13, 2021, the true deadline for filing the Opening Brief would move to Monday, November 15, 2021. This is the first request for an extension of time to file the Opening Brief.

Counsel's request for an extension of the time to file the Opening Brief is twofold. First, on June 1, 2021, Counsel filed a request to obtain the court transcript for the October 10, 2021 Hearing regarding Mr. Muhammad-Coleman's Petition for a Writ of Habeas Corpus, that took place in Eighth Judicial District Court, Department 10 ("District Court"). Unfortunately, Counsel did not realize that this transcript request was improperly served on the District Court, which has delayed the preparation of those transcripts. Counsel has since corrected this deficiency, however, the transcripts have still not been prepared or provided to Mr. Muhammad-

Coleman, although Counsel has been told to expect the transcripts imminently. Without this transcript it is impractical, if not impossible for Mr. Muhammad-Coleman to file a complete and sufficient Opening Brief detailing in full all applicable issues in this matter. Therefore, Counsel respectfully requests that this sixty (60) day extension request be granted, so that Counsel has sufficient time to review the District Court transcript and fully prepare and finalize Mr. Muhammad-Coleman's Opening Brief.

Additionally, Counsel requests this sixty (60) day extension so that he may confer in person with his client, Mr. Muhammad-Coleman, who is currently being held at the Ely State Prison. Due to the ongoing COVID-19 pandemic, the Nevada Department of Corrections has been forced to implement restrictions limiting the amount of in-person visiting inmates may receive, including in-person visits between counsel and their clients. However, these restrictions on in-person visits have recently been lifted, and Counsel is scheduled to meet with Mr. Muhammad-Coleman in-person on Friday, September 17, 2021. While Counsel has discussed this appeal with Mr. Muhammad-Coleman telephonically on numerous occasions, it is Counsel's belief that an extended and face to face meeting will greatly aid the preparation of Mr. Muhammad-Coleman's Opening Brief.

Thus, in addition to the need to wait for the District Court transcript, Counsel is requesting this sixty (60) day extension to file the Opening Brief so that he may confer in-person with Mr. Muhammad-Coleman regarding his Appeal.

CONCLUSION

Pursuant to the arguments above, Appellant, Darion Muhammad-Coleman, respectfully requests that this Court extend the time to file an Opening Brief in this matter until to November 15, 2021.
