## LEGAL ARGUMENT

Nevada Rules of Appellate Procedure Rule 26 (b)(1)(B) allows this Court discretion to enlarge the time to perform any act more than once, including filing of the Opening Brief, based upon extraordinary or compelling circumstances. This Honorable Court docketed this matter on May 17, 2021, and pursuant to Nevada Rules of Appellate Procedure Rule 31 (a)(1)(A), the Opening Brief was due on September 14th, 2021. Appellant requested, and this Court granted, an extension until November 15, 2021, to allow for the completion of transcripts necessary to prepare the instant appeal. The request for transcripts was thereafter promptly reserved. On November 1, 2021, the remaining transcript in this matter was filed, and compiled into the proposed Appendix for this matter. Upon information and belief, preparation of the aforementioned required more time than anticipated (given the previously requested sixty days) and was not within Appellant's control. Moreover, Appellant is in custody, limiting any prejudice incurred by the State, should this Court grant the instant Motion. As a result, counsel seeks additional time to properly prepare the Opening Brief and Appendix, to provide to this Court a through record. It is anticipated that the same will require forty-five days, given that counsel anticipates announcing ready for a jury trial that commences on December 6, 2021, which will hinder counsel's ability to prepare the instant matter for a short time.

Finally, this is the second request for an extension of time to file the Opening Brief, which would be due on December 30, 2021, if granted.

**CONCLUSION**

Pursuant to the arguments above, Appellant, Darion Muhammad-Coleman, respectfully requests that this Court extend the time to file an Opening Brief in this matter until to December 30, 2021.
